### Floyd County ballot now full

The filing deadline for candidates seeking office was 4:30 p.m. on Tuesday, and Floyd County's ballot placement drawing will be held Feb. 1.

Eighteen candidates recently filed paperwork to seek offices serving Floyd County residents, bringing the total number of candidates seeking election to 68. The majority of these newly-filed candidates submitted their paperwork after 12 p.m. on deadline day.

The newest filings added two Court of Appeals candidates, who will face off with five others in November, as well as two additional candidates for Floyd County Judge Executive and jailer, and new candidates for Magistrate District 1, 2 and 4, Constable District 1 and 4, and other county offices.

### Floyd BOE rejects bids for school properties

The Floyd County Board of Education recently rejected all bids it received for schools and properties that are no longer in use.

During a Jan. 22 meeting, the board rejected four bids for three schools that are closed and a former maintenance building in Allen.

The action came at the recommendation of Interim Superintendent Steve Trimble, who said the bids came in much lower than anticipated. He recommended the district seek guidance from the KDE on how to move forward.

The board of education de-

last July and the Kentucky Department of Education approved that action in October. Sealed bids were opened on Dec. 18.

The highest bid was a \$100,000 bid submitted by Danny Meade of Mays Branch in Prestonsburg and Mike Vanderpool of Crestwood Drive in Prestonsburg, for the Osborne Elementary School property in Bevinsville. They are both affiliated with H&C Construction, with Meade serving as vice president and Vanderpool incorporating the business, the Kentucky Secretary of State reports.

One company, J&S Property Management, with an address of 109 Left Fork of Toler Creek in Harclared the properties as surplus old, submitted two bids: \$7,000 for

McDowell Elementary and \$8,100 for the old Allen Elementary school building, which has been vacant for years in the city limits of Allen.

The District's Director of Facilities Greg Adams said he could not read the names of the individual who submitted bids for that property management company. It is not registered with the Kentucky Secretary of State and does not appear to have a website.

A Floyd County Maintenance Department Technician, John Campbell, also submitted a \$5,050 bid for the old maintenance building in Allen. Campbell lives in that cit v.

After rejecting the bids, Trimble said the district will seek advice from the KDE, a process Adams said could take two months.

"I'm assuming they'll tell us to rebid," he said after the meeting. "I don't know that for a fact, but I'm just guessing from past occasions."

He said the properties were appraised in May 2017, but he refused to provide details of appraisals, saying he didn't want to do anything that could prevent the district from getting as much as possible for the properties.

"The bids were nowhere near the appraised values, probably not even two-thirds of the appraisals," he said.

The school district continues to fund insurance policies for these properties.

### Beshear correct to sue drug company in opioid fight

Years ago, it was common to open this newspaper and read about methamphetamine busts and, in some cases, deaths related to meth overdoses or explosions from a meth cook that occurred in houses where children were living.

Thankfully, we don't hear quite as often about meth arrests anymore. A large reason for that is because Kentucky got tough on meth by passing laws to make it harder to obtain the products needed to produce it. But as locally produced meth is replaced by meth coming from Mexico, there is increasing concern about other hard drugs.

Heroin and other opioids have hit Kentucky hard in recent years, claiming many lives during that time. This drug problem is especially bad in northern and eastern Kentucky. Some have argued that these drugs became more popular after the state passed Kentucky All-Schedule Prescription Electronic Reporting. KASPER, to its credit, did a good job hampering meth,

but its indirect effect has been the rise of other drugs.

It has been obvious for some time now that we must do more to curtail the availability of heroin and other opioids because too many lives are being taken. Some law enforcement officials refer to this as an epidemic and we would agree with their assessment.

More than 1,400 people died in Kentucky from drug overdoses in 2017, a 39 percent increase in just three years. The biggest culprit in these deaths was opioids, including prescription painkillers, heroin and fentanyl, a synthetic form of the drug that is more potent. It's also worth mentioning that Kentucky ranks fourth lowest of the 50 states for workforce participation. This could be attributed to the fact that the opioid epidemic is becoming the human capital crisis of our time.

These numbers show definitively that we have a serious problem on our hands that will take a long time to overcome. One person we believe is doing his part to help combat these deaths is Kentucky Attorney General Andy Beshear.

Beshear is suing McKesson Corp., a San Francisco-based pharmaceutical distributor, in state court, accusing the company of using misleading business practices to flood the state with dangerous and highly addictive prescription drugs and failing to report suspiciously large volumes of opioid shipments to state and federal authorities.

Beshear cites Floyd County as just an example. There are just more than 38,000 people living in Floyd County, located in the mountains of Eastern Kentucky. Yet between 2010 and 2016, McKesson shipped more than 18 million doses of opioid painkillers there, enough for each person to have 477 pills each. Beshear says that was illegal. Beshear made a very good point when he said, "These numbers are glaringly obvious. No responsible company would have seen these numbers and think: 'All is well.' ...

Our lawsuit alleges they knew exactly what they were doing. They knew they were flooding these communities with dangerous and addictive drugs, and we've paid the price."

Beshear's lawsuit in Franklin Circuit Court says McKesson is supposed to "monitor, identify, halt and, perhaps most importantly, report suspicious orders of controlled substances." He said this did not happen, pointing to outsized supplies of opioids shipped to five eastern Kentucky counties. Altogether, those counties received more than 53 million doses of prescription opioids. Those counties have a combined population of 120.381.

McKesson spokeswoman Kristin Hunter Chasen said the company is just one link in the pharmaceutical supply chain, and that it distributes opioids only to pharmacies that are licensed with the state and registered with the U.S. Drug Enforcement Administration. She pointed to a statement on the com-

pany's website saying allegations that McKesson fueled opioid abuse are unfounded.

It appears that more safeguards need to be put in place by McKesson to monitor the amounts of opioids it is shipping to these counties. We don't know their policies, so we won't say they aren't doing this already. Perhaps doctors in these counties who overprescribed share some responsibility as well? They are, after all, the final link in that supply chain. Don't they need to act as monitors and make responsible decisions on how many opioids they prescribe? We certainly believe so.

Obviously, only time will tell if Beshear and the state will prevail in this lawsuit, but we are glad he is bringing the issue to the forefront in an effort to fight this epidemic.

### Senate week in review

The tone was somber in Frankfort last week as we mourned the tragedy that struck Marshall County. We were overwhelmed with compassion for that community whose sense of safety has forever been tainted by gunfire. We can only imagine the heartbreak and sorrow felt by the family and friends of the two 15-year-old victims senselessly slain. The loss of these two young people – Bailey Holt and Preston Cope - is heart rendering. In the midst of the emotions, we found that disaster brings us closer and creates a bond. On the day of the shooting, Senator Danny Carroll was absent from our chamber because he had gone to Marshall County to be with the people he represents. While he offered them solace, we too sent our prayers and support to them. As we stood in silence on the Senate floor, we were neither Democrats nor Republicans. We were Kentuckians

— parents, grandparents, brothers, sisters and friends - grieving in the aftermath of a horrific event.

We cannot change what happened on Tuesday in Marshall County, but we will continue to send that community our prayers of consolement and our hope for healing.

Even as we mourned, we had to resume our work that make up the executive in Frankfort. We are still branch. That analysis includwaiting on a bill from the ed what cabinets suggested Senate and House Republicans to address our pension problem. The Governor set the tone almost a year ago, saying he would call a special session before we convened in 2018 to address the public employee and teacher pensions, but there is still no bill. And, as we mull over the pension issue, we are still trying to understand the Governor's "train wreck" that he calls a two-year budget.

for 70 programs, including colon, lung and cervical cancer screenings, Kosair Children's Hospital poison control center, Robinson Scholars Program and other scholarships, and various services for disabled children. State Budget Director John Chilton said the 70 programs were chosen after an analysis by his office and the cabinets ballot this fall, has passed both chambers and been delivered to the Secretary of State's office to begin the process of putting it on the ballot.

Action on the Senate floor this week included the passage of Senate Bill 73. The first part of this legislation would allow school districts to come up with a three-year pilot project for teachers' professional development, require the local board of education to determine the parameters for the pilot program and require the state education department to study the completed pilot projects and report its findings by August 2022. The goal, in part, is to provide teachers with the professional development they need to improve their craft. The second portion of the bill phases out the socalled nontraditional instructional days, or NTI days. The days were meant to enable students to continue their studies when schools were closed because of bad weather. About five years ago the General Assembly approved snow-day legis-

lation that allowed school districts to use technology-based learning approaches on up to 10 school days.

Some school districts have provided assignments that are more rigorous for students than other districts and this has caused disparities in learning. The goal of this section of SB 73 is for all school districts to embrace the program so legislators can extend it beyond its sunset date of 2020-21. Another education bill, Senate Bill 71, would require the inclusion of abstinence education in any human sexuality or sexually transmitted diseases curriculum taught in our public schools. The passage of this bill will emphasize the importance of abstinence and monogamous sexual relationships. This will give our children time to maturate mentally, physically, sexually and emotionally before engaging in sexual activity. Supporters said it was a common-sense measure because abstinence prevents unwanted pregnancies and inhibits the spread of sexually-transmitted diseases. They added that

teaching such values help children develop their moral compasses to help transform them into functional adults in society.

Senate Bill 78 changes the educational standards for electricians by creating a provisional license for people with a minimum of six years of experience in the trade. The provisional license holder would have one year to pass a state exam and get a regular license. An additional clause in the bill would allow some electricians, whose licenses have lapsed, to have their licenses reissued. I could not support this bill because SB 78 lowers the standards for licensed electricians - a move that is a public safety hazard. In the weeks ahead, the number of bills being vetted in committee and on the chamber floor will increase. Your input is more important than ever. The Senate Appropriations and Revenue Committee held its first hearing on the Governor's proposed budget. It would impose a 6.25 percent across-theboard cut to most state agencies and curtail funding cutting when asked in September to prepare for a 17.4 percent budget cut that was never fully implemented.

The appropriations and revenue committees from both chambers are currently combing through the Governor's budget proposal. The House will present its version of the state's two-year spending plan in the weeks to come.

As we continue divina into the executive budget proposals, we have made progress on legislation. Senate Bill 3, or Marsy's Law, which would allow the question of state constitutional rights for crime victims to go on Kentucky's statewide

### Shoplifting duo appears in Floyd Circuit Court for sentencing

#### BY JOSH LITTLE STAFF WRITER

A Floyd County duo appeared in Floyd Circuit Court Thursday on charges relating to an alleged shoplifting spree.

Joseph Serrano, 33, of Printer, and Andrew Crum, 31, of Drift, were apprehended following a complaint of a shoplifting attempt from the Auto Zone store in Prestonsburg in January 2017 and another complaint of individuals in the same vehicle the following day in the plaza near the Walmart store in Prestonsburg, according to Floyd County Commonwealth Attorney Brent Turner.

"(Officers) located a vehicle parked near (the former) Reno's (Roadhouse) and Serrano was driving the vehicle and around that time the barber shop (near Walmart) called and said they thought someone had crawled underneath their floor," said Turner. "Police went there and found Crum hiding under the building."

Turner said Crum gave a detailed explanation to officers of what the duo had been doing. During his statement,

he said the two had been shoplifting from multiple places and then would trade the shoplifted items for drugs, Turner said. He said Serrano's testimony to officers was less detailed.

"(Serrano) didn't really deny the thefts, but he said he was on drugs and high a lot of the times and he didn't really remember everything they did," Turner said.

The duo was originally charged with organized crime, which was amended to complicity of theft by unlawful taking over \$500, for Crum and Serrano.

Crum was sentenced Thursday to three years in prison on a charge of third-degree burglary, and three years on a charge of complicity of theft by unlawful taking over \$500, both of which are Class D felony charges. The sentences will run concurrently.

A sentencing hearing for Serrano is set for 1 p.m. Feb. 22 in Floyd Circuit Court. Turner said he is recommending a two-year prison sentence for Serrano. Serrano has pleaded guilty to complicity to theft by unlawful taking greater than \$500.

In partisan races, candidates in six Floyd County offices — County Attorney Keith Bartley, Commonwealth's Attornev Arnold Brent Turner. Coroner Greg Nelson, Property Valuation Administrator Connie Hancock, County Clerk Chris Waugh and Sheriff John P. Hunt - face no opposition. But the ballot is quite full in other races for seats that serve Floyd County residents.

There will be two primary elections for the U.S. representative race for the 5th Congressional District, incumbent Harold "Hal" Rogers faces Gerardo Serrano of South Tyner in the Republican primary and Democrat Kenneth S. Stepp will face Scott Sykes of Elkhorn, who filed his paperwork on deadline day. The winners of those primary elections will face each other in the fall.

In the Kentucky House race for the 95th representative seat, incumbent Larry D. Brown has no Republican opposition in the May primary, but he is set to face Democrat Ashley Tackett Laferty of Martin in the fall.

Napier arrested Raquel Renee Cain, a special education teacher at RLC on Jan. 25, following a K-9 search of the school by the Floyd County Sheriff's Department, court documents show.

RLC Principal Jerry Butcher said the Floyd County Sheriff's K-9 Unit was scheduled to search Floyd Central High School on that day, but because administrators at that school were dealing with a possible threat at that school, the K-9 unit searched RLC instead. The search was part of a system of random searches that the sheriff's department offers at all county schools, Butcher confirmed.

Butcher said the K-9 Unit searched the school and Susan Damron, who oversees Student Support Services at RLC, joined the K-9 Unit in the school's parking lot. Butcher said he was called to the parking lot after the K-9 Unit signaled that drugs were possibly in Cain's vehicle.

He said he removed Cain from her classroom and took her downstairs, where she was arrested at 2:42 p.m. He said school

officials held buses that day so the students did not witness the arrest.

"The kids could hardly believe it," Butcher said.

Martin Police Chief Michael Napier said the search was random and that no illegal drug use was suspected

Because the dog picked up on something inside of Cain's vehicle, officers had probable cause to search, police said.

Upon entering the vehicle, Napier said officers located particles of marijuana, or "shake," in the floorboard, a straw with a light colored residue on the end, which Napier said was suspected to be a controlled substance.

The straw was sent to the Kentucky State Police laboratory to be tested, Napier said.

According to Napier, residue was present in both of Cain's nostrils.

Napier said sobriety tests were performed on Cain.

"She was showing indicators of having taken something earlier," said Napier.

When the officers ran Cain's information, they discovered she had two warrants out against her. Napier said one was a bench warrant for missing a court date and the other was related to a theft charge. Cain was then lodged in the Floyd County Detention Center. A charge of first-degree felony possession of a controlled substance was filed in connection with the arrest.

She has two other pending cases in Flovd County District Court, each stemming from two complaints filed by a private citizen, in which she is charged with stealing a television and an iPad, and one of which resulted in one of the warrants served against her last week.

On Aug. 21, the day Floyd County students returned to school, Cain appeared in court for both cases, and was ordered to attend drug treatment. In the felony case, the charges were set to be diverted if she completed a 90-day treatment program. A review was scheduled to be held in the case in October, but she did not appear for that hearing and it was rescheduled for March. She also did not appear for the court trial scheduled for December 28 in the misdemeanor theft case and the bench warrant issued for that failure to appear was served when she was arrested at RLC.

Cain has been employed with the Floyd County School District for years, first as a homebound teacher and later as a special needs teacher at RLC. She also served in 2014 as an itinerate special needs instructor both at RLC and Duff Elementary. She obtained her Rank II certification in 2005, was hired as a home hospital instructor in 2008 and earned certifications in special needs education in 2013. Her certifications are set to expire in June.

The Floyd County Board of Education renewed Cain's contract as a special education teacher at RLC on July 24, 2017.

On Sept. 25, the board of education approved Cain for family medical leave, scheduling it for between Aug. 24, 2017 and Nov. 27, 2017. Butcher reported, however, that she did not work at RLC during the first semester of school. He said she started working at the school on Dec. 11, and continued working there until her arrest at the school.

Interim Floyd County Schools Superintendent Steve Trimble would not comment on Cain's arrest. He did, however, confirm that she is still employed with the Floyd County School District. He would not confirm whether she has been suspended.

The Jan. 25 K-9 search

was the school's first drug search this year, Butcher said.

Butcher, who started working at the school this year, said staff told him they had not been drug tested for several years.

"They hadn't had drug testing up here for four or five years," he said. "So, I got together with the superintendent at the first of the year and told him I wanted drug testing. He told me there wouldn't be a problem."

He said the school takes the use of illegal drugs seriously.

"We want people to know that we are following our policies up here and this school is safe," he said. "We are a drug-free school and we don't tolerate the use of drugs here."

Cain was charged with possession of a controlled substance.

Cain has two other pending cases in Floyd County District Court, both related to warrants taken out against her by another private citizen. She is scheduled to appear in Floyd District Court at 1:30 p.m. Wednesday for a preliminary hearing. The other two cases against Cain are expected to be reviewed at that time.

### BSADD wants to expand its Revolving Loan Fund program

Facing the possibility of losing unused funds, the Big Sandy Area Development District wants to expand its Revolving Loan Fund program.

This fund is available to new and expanding businesses in Floyd, Pike, Martin, Magoffin and Johnson counties, offering flexible financing to bridge funding gaps or help businesses obtain other types of loans.

But officials report that businesses in the Big Sandy region aren't utilizing the fund, causing the federal government to sequester unspent funds and leaving Big Sandy ADD with a possibility that those funds, if left unused, could be swept back up into federal government coffers.

During a Jan. 23 meeting, the Big Sandy

approved asking the federal government to allow the expansion of the program into the Kentucky River Area Development District, which serves Perry, Letcher, Knott, and five other counties. The Kentucky River ADD does not offer a Revolving Loan Fund program.

The board also approved other changes to the program, including adding veterans to the list of potential clients, adding four new members to the Revolving Loan Fund committee and

changing the ratio of the number of jobs created or retained to the amount of funds loaned out from \$10,000 per job created or retained to \$20,000 per job created or retained.

The approval came following a recommendation from the Big Sandy ADD's Revolving Loan excess funds when the

ADD board of directors Fund committee, which previously approved the program changes, and after Certified Public Accountant Lynette R. Schindler of Pikeville encouraged the agency to spend its unused Revolving Loan Fund money.

Presenting the 2017 audit to the board of directors, Schindler explained that the Big Sandy ADD currently has only one outstanding loan in that program—a \$26,000 loan made available to Pig in a Poke III in 2011.

"You also have a Revolving Loan Fund which you all need to loan out," she told the board.

Big Sandy ADD cooperates with local banks to establish the program, which is funded by the U.S. Department of Commerce's Economic Development Administration. That federal agency sequesters, or puts aside,

in the Revolving Loan Fund account exceeds 25 percent of the program's capital base for more than a year.

The Big Sandy ADD received \$457,500 in federal funds for the program during the last fiscal year and that amount was matched with \$152,500 in funding from partnering banks. The amoaunt required to be sequestered by the EDA on June 30, 2017, was more than \$267,000, Schindler reported.

EDA wants "The money put aside. They call it sequestering," she said. "And they wanted \$267,000 sequestered and put aside that they could conceivably come back and say, 'Give it to us. You aren't loaning it out. We want it back."

Big Sandy ADD Director Sandy Runyon said the

amount of cash available other changes are expected to improve it. She said it's a "very good pot of money" that can help Eastern Kentucky businesses grow.

> "It's under-utilized because the economy, a lot of different factors, I think, were in there together to cause that to be an almost inactive pot of money," she said. "We believe that if we submit a plan to the Economic Development Administration and ask them to allow us to make some changes within that, that might make that money a little more palpable for small businesses to begin."

> The Big Sandy ADD currently has about \$370,000 in Revolving Loan Funds, officials reported, and \$267,000 is still sequestered.

"And we are proposing if they will allow us to expand into the Kentucky program expansion and River area, we're proposing to use those sequestered funds in the Kentucky River area," Runyon said. "The primary funds will still be used here. They can be used anywhere, but that's the ones we're proposing to use in the Kentucky River area."

Revolving Loan Fund committee is currently made up of lenders participating in the program. If approved, the new Revolving Loan Fund members will include representatives from the Mountain Association for Community Economic Development, One East Kentucky, Shaping Our Appalachian Region and local government economic development staff.

"Kentucky HEALTH introduces innovative delivery system reforms for the treatment of substance abuse, and a first-ever community engagement initiative for Kentucky HEALTH members designed to improve their health and strengthen Kentucky's workforce," a press release announcing the approval of the program said. The lawsuit, however, alleges that the transformative goals of this program violates federal laws and rights of citizens. "Kentucky was candid about its goal: it aimed 'to comprehensively transform Medicaid," the lawsuit states. "True to its word, Kentucky HEALTH program sought to radically alter Medicaid in Kentucky, including requiring Medicaid enrollees to work in order to receive health insurance and by imposing new and substantial premiums and restrictions." The Center for Medicaid Services received more than 3,000 comments on that proposal before Jan. 11, when the comment period closed for the Kentucky HEALTH application. On that day, the director of the Centers for Medicaid Services announced a new approach, the lawsuit explains.

Woods, 40, of Martin, and Lakin Branham, 20, of Dwale, joined the lawsuit with 13 other Kentucky residents who claim Kentucky Medicaid waivers recently granted by the federal government are unconstitutional.

The lawsuit was filed in the U.S. District Court for the District of Columbia against officials with the U.S. Department of Health and Human Services, the Centers for Medicare and Medicaid Services and the Center for Medicaid and CHIP Services. The Kentucky residents named in the lawsuit are represented by the National Health Law Program, Kentucky Equal Justice Center and the Southern Poverty Law Center.

Gov. Matt Bevin submitted an application to the U.S. Department of Health and Human Services in 2016, requesting a waiver of Medicaid Act requirements to establish the "Kentucky "Helping to Engage and Achieve Long Term Health (HEALTH) program, which, among other things, requires Medicaid recipients to work in order to qualify for benefits.

The plan is expected to reduced Kentucky's Medicaid enrollment by 95,000 and reduce payments for healthcare by about \$2.4 billion.

Bevin touted the program as one that would

pressed view of the need to 'fundamentally transform Medicaid,' Defendants issued a letter to State Medicaid Directors announcing CMS's intention to, for the first time, approve waiver applications containing work requirements and outlining 'quidelines' for states to consider in submitting such applications."

Kentucky's waiver was approved on Jan. 12, without the agency seeking comments on the "radical expansion of the Medicaid waiver authority," the lawsuit alleges.

It alleges the approval of Kentucky's waiver and the letter outlining sent by CMS are "unauthorized attempts to rewrite the Medicaid Act."

It further alleges that the use of the statute's waiver authority to "transform" Medicaid is "an abuse of that authority."

Kentucky is one of 31 states that approved expanding Medicaid under the Affordable Care Act, and the lawsuit alleges that once a state decides to expand coverage through the ACT, it becomes a "mandatory coverage group."

The lawsuit claims Kentucky HEALTH has been designed as a "high-deductible commercial health plan." The alleges that states that states cannot "impose additional eligibility requirements," other than those already detailed

population group."

It explains that Medicaid provides health insurance to more than 75 million low-income people in the U.S., and it predominately serves children, pregnant women, the disabled and adults with household incomes of less than 133 percent of the federal poverty level.

The Floyd County residents named in the suit are listed along others from Lexington, Louisville, Radcliff, Berea, Bowling Green, Salyersville, Park Hill, Ludlow and Ashland, and it details how each of them rely on that program.

The Woods couple, who earn only \$1,800 monthly, from a service station Michael Woods owns and from cleaning that Sara Woods provides, signed up for Medicaid in 2014. Neither of them had health insurance prior to that time. Under Kentucky HEALTH, they would be required to pay four percent of their income for Medicaid coverage.

The lawsuit explains that Sara Woods receives treatment for a substance abuse disorder with Medicaid and that Michael Woods is able to access preventive services.

With the new requirements, they would have to report any change in income within 10 days, which "will be difficult since their income changes every day," the lawsuit

cell phones and do not have access to a computer or internet other than through their cell phones," the lawsuit states. "If a non-reported increase in income would make them ineligible, or if they fail to complete the redetermination process on time, they will be locked out of Medicaid."

Branham, the lawsuit says, helps care for her grandfather, who has terminal cancer, as well as other elderly family members. She is unemployed and has no income. She enrolled in Medicaid in 2015.

The lawsuit explains that she, too, receives substance abuse treatment through Medicaid and she wants to return to college and become a substance abuse counselor. The lawsuit states that she would not be able to continue caring for her grandfather and attending outpatient substance abuse services if she is required to work 80 hours per month. It also notes that she cannot afford the \$1 monthly premium or any co-payments she would be required to pay for healthcare services.

The lawsuit claims the plaintiffs violated the Administrative Procedure Act by sending out that letter, by establishing "lockout penalties," by refusing retroactive coverage, and by approving waivers that require Medicaid recipients to for something that is not deemed a medical emergency.

It also claims violations of the Take Care Clause, a clause that limits the President's power and ensures he will execute laws that Congress has passed.

"Under the Constitution, the President lacks the authority to rewrite congressional statutes or to direct federal officers or agencies to effectively amend the statutes he is constitutionally required to execute," the lawsuit states.

Bevin and other state officials hosted a roundtable discussion with about Kentucky HEALTH on Jan. 24 in Frankfort with U.S. Department of Health and Human Services Eric Hargan, who is named in the lawsuit.

"Kentucky HEALTH is an innovative approach that will put Kentuckians on a path to better health, and is key to ensuring the long-term viability of the Medicaid program," a press release about that event said. "In addition, Kentucky HEALTH will ensure availability of Medicaid resources to our most vulnerable citizens by saving an initial estimated \$2 billion (federal and state) over the waiver demonstration period, allowing these funds to be focused on those most in need and other critical areas.
