After returning from closed session Monday, the Prestonsburg City Council heard a motion to allow Mayor Les Stapleton to enter into a lease agreement with the Commonwealth of Kentucky for the city to take over the lease for the amphitheater located in the Jenny Wiley State Resort Park.

In January, the Kentucky Department of Parks announced the temporary closure of the amphitheater at the park citing repairs that needed to be addressed before allowing the facility to be used.

Monday, Stapleton said that the City of Prestonsburg "could not afford to lose the amphitheater as a tourist attraction."

Would place 'panic buttons' in schools

The City of Prestonsburg will soon incorporate software that will change the way first responders in the city do their iob.

At Monday's meeting of the Prestonsburg City Council, the council was introduced to Rave Mobile Safety's Smart911 by Mayor Les Stapleton.

"It's an enhanced 911 system," Stapleton told the

# **Out of bounds?** Former Pike County basketball coach alleges recruiting violations, reprisals in deposition

PIKEVILLE — A civil lawsuit filed in Pike Circuit Court by the former assistant principal and boys basketball coach of

Pike Central High School has Road, Varney. revealed details of alleged recruiting being orchestrated by a local business owner. The filing has helped to shed light on allegations of alleged recruiting and placement of high school basketball players by Kentucky BCI Basketball owner David Clevenger, of Brushy

For this story, the News-Express attempted to reach Clevenger at a number provided for Kentucky BCI Basketball without success. Additionally, school officials were not made available to speak with the News-Express due to the ongoing whistleblower lawsuit.

According to the lawsuit filed by Keith May, former assistant principal and basketball coach for the Pike Central Hawks, his reporting of violations to his superiors led, first, to his not being retained as the basketball coach and, then,

# **Coal is on the move in Eastern Kentucky**

The Kentucky Energy and Environment Cabinet's latest coal report shows that coal mining operations are increasing in Floyd, Pike, Perry, Johnson and surrounding counties.

The agency's quarterly coal report shows that Kentucky coal mines produced about 42 million tons in 2017 - a decrease of 1.6 percent from 2016. Production at underground mines fell by 3.4 percent, around 31.6 million tons, statewide.

Most of the decreases, however, were seen in the western Kentucky coalfields, which mined about 9 percent less coal than in 2016.

production topped nearly 18.5 million tons in 2017, an increase of 9.4 percent over last year. Most of that coal, more than 10 million tons, was mined underground.

Pike County topped the Eastern Kentucky coal production list with more than 4.5 million tons, an increase of 15.1 percent over the prior year, followed by a 13 percent increase in Perry County coal production, which topped more than four million tons in 2017.

Floyd County ranked fifth among 19 Eastern Kentucky counties in total coal production in 2017, with nearly 1.2 million tons mined in the county that year, an increase of 83.8 percent over the prior year.

by 23.3 percent in Pike County, 14.4 percent in Perry County, 4.1 percent in Floyd County and 41.2 percent in Johnson County.

Statewide, 6,503 people were employed in the coal mining industry, an increase of 0.7 percent since 2016.

Although these local counties saw increases in coal production, mining decreased in six other local counties. Comparing mining production from 2016 to 2017, there was a coal production decrease of 44.6 percent in Martin County, 41.5 percent in Knott County, 77.5 percent in Magoffin County, 50.5 percent in Lawrence County, 41.4 percent in Laurel County and 24.6 percent in Pulaski County.

## Floyd man appears in Pike court as wife remains on run

A Martin man who was indicted in Pike County on charges including he stole money and a van from a Pikeville church appeared in Pike Circuit Court Friday as his wife has remained on the run from the law three months after her husband's arrest.

John Allen, 46, of Martin, was arrested in South Williamson in No-

vember as he and his wife, Michelle Allen, aka Deputy Jackie Deskins Michelle Fowler, 43, and young daughter were located shoplifting from a store in the city. While inside of the store, John Allen had also tried to cash a check which had been registered as stolen from the church, along with a church bus, which had been entered as stolen into the National Crime Information Center, the citation said.

Pike County Sheriff's wrote in his citation that, when he went to his vehicle to check for any warrants against John Allen, Allen attempted to run. According to the citation, Deskins, two employees and another officer pursued John Allen and caught him before he was able to make it to his wife's vehicle. During the foot chase, however, Michelle Allen fled in a vehicle, the citation said.

Michelle Allen has remained on the run from the law since that evening.

The pair were indicted in December on a felony charges of theft by deception and John Allen was also indicted for felony theft and being a persistent felony offender in the first degree.

On Friday, John Allen, with defense attorney Joseph Lane, appeared in the courtroom of Pike Circuit Judge Eddy Coleman after Allen filed a "pro se motion" to have his bond in the case reduced from an original bond set at \$45,000 full cash.

He has a two-year-old child. When he first came to Kentucky he was on a federal probation which he has since completed."

Lane asked for a 10 percent bond, a requirement or payment which John Allen believed he could make.

Pike Commonwealth's Attorney Rick Bartley had cited John Allen's connections to New York and New Jersey, where he had previously been charged in armed robberies, as reasons why, Bartley believed, John Allen would not remain in the area if released on bond.

"Mr. Allen has only been here for a few years

connection to this area whatsoever" when he came into Eastern Kentucky, except he started living with a family. That family had a falling out and started taking out warrants against each other, Bartley said, thus, that family is no longer an option to him.

"He came here for a while and resided with that family, but he left that family and had to go to the homeless shelter because he had so few contacts," Bartley said. "In the meantime, he met and married a local woman from Floyd County. I will note that Michelle Allen is still on the run some months after we returned this indictment. She is his co-defendant, his wife and the mother of his child. I think if we let him out, he and Michelle are going to jump and run and we'll never seen either one of them again, by the actions of his wife." Coleman said he would take the motion under advisement and make a decision on bond at a later date. Allen was returned to the custody of the Pike County Detention Center where he has remained since his initial arrest in the case.

# Man allegedly found with illegally taken deer

A Harold man who was arrested for allegedly stealing a trail camera Saturday faced additional charges after Kentucky Fish & Wildlife officials allegedly found him in possession of two deer skulls.

According to court records, Timothy Akers, 60, of Toler Creek Road, Harold, was arrested by officers with the Pikeville Police Department on a charge of receiving stolen property, which included a trail camera at an area off of Ky. 1046, Chloe Road.

PPD officers reported Akers to Kentucky Fish & Wildlife Officer Robbie Spears II after the PPD officer located

two deer skulls, the citation said.

Spears wrote in his citation that Akers "didn't have any information or confirmations number for the skulls."

Court records show Akers was arrested on charges of receiving stolen property (under \$500), acts of depredation while hunting/fishing/trapping, entry on land to shoot/hunt/fish/trap without consent and third-degree criminal trespassing, as well as two charges of illegal taking/pursuing a deer/wild turkey.

Akers was booked into the Pike County Detention Center Sunday before being released on his own recognizance with orders to appear at arraignment in Pike District Court at a later dater, according to court documents.

# Prestonsburg to annex property

Prestonsburg The City Council Monday heard its first reading of two ordinances that would allow the city to grow geographically by annexing property.

The property seeking to be annexed includes the territory of Spradlin Branch and the territory of the Lakeview Village Subdivision.

A concerned citizen addressed the council Monday about the annexation of Spradlin Branch. She said she had received a letter notify- to not do the annex-

ing her about the annexation and asked if the council could section the area off because, "some people do not want to be annexed."

Prestonsburg Mayor Les Stapleton said that a second reading of the ordinance would be held in March. After the second reading, there is a 60-day period that allows residents in the proposed area to petition, Stapleton said. The petition would allow the annexation to be placed on a ballot during the next general election.

"This is not a process

ation," said Prestonsburg City Clerk Sharon Setser. "You're going to ask the mayor to have it placed on the general election ballot. So, then, it will be up to the registered voters to decide whether or not they want that to be annexed."

Setser said all property owners in the proposed annexation area will be receiving information in the mail soon.

The second, and final, reading of the annexation ordinances is scheduled for the council's March 19 meeting.

"We're going to try to negotiate (a lease) so that we can have it repaired and to get it operational," Stapleton said, after Monday's meeting. "At that point, we will have a sublease with the Jenny Wiley Theatre."

In a press release issued in January, state officials reported that the amphitheater needs electrical and structural repairs — problems that were discovered during a recent inspection that was prompted by safety issues discovered at another state-park based amphitheater.

"As soon as we became aware of the hazardous condition of the amphitheater at My Old Kentucky Home State Park, we sent our inspectors to the amphitheater at Jenny Wiley State Resort Park," said

Arts and Heritage Cabinet. "What they reported back to us leaves us no other option but to restrict all access to the theater. We are making certain our guests and employees are not exposed to a dangerous environment."

Upon inspection, Jenny Wiley Theatre Managing Director Darryl Willard said, numerous "minor repairs," like replacing rotten boards and installing plates over electrical outlets, were cited in the state's inspection report, and he does not believe those problems will keep JWT from performing two plays scheduled for the amphitheater this summer. He estimated repairs of nearly \$10,000.

The motion would allow the council to review the lease agreement prior to it being signed by the mayor.

audience and board members during the meeting. "The assets to this (software) are unbelievable."

Smart911 is a software that would allow first responders to respond more quickly by providing them with more information about callers and injured persons. Prestonsburg residents will create a free profile account online to provide the software with phone numbers, both home and work addresses, family member information, photos, medical conditions, disabilities and pet information.

Stapleton said he and some of the council members recently participated in a conference call with the company. He said the software would cost the city \$1,000, with an annual fee of \$7,000.

Stapleton said the software will make responding to cell phone quick.

"As of right now, if someone calls us from

a cell phone, there's not an address attached to it," he said. "If they go online and fill out the information sheet, not only would it say that (the caller) is in one of two places - this is where he lives; this is where he works - those (addresses) will be attached to his cell phone if he calls 911. It will also have an opportunity for him to put in information... it could have a complete listing of his medical record."

The software also works with land lines. Participants can also use the service for text messaging instead of making phone calls.

In addition to these services, the company would also place "panic buttons" in Prestonsburg schools. Stapleton recalled one case study in which a student had a gun at school and was apprehended within eight minutes of one of the "panic buttons" being pressed.

# Too common

# School violence, campus shootings and threats are becoming the norm, and we must act to turn that back

Last week, we were still reeling from the news of a school shooting just six hours away in Marshall County which left two teenagers dead late last month. After all, it was close enough to home for us to be able to realistically consider the possibility that something like that could indeed happen here.

And then, last Wednesday, Valentine's Day, according to law enforcement, a shooter walked into a high school in Parkland, Florida, and began firing an AR-15, leaving 17 people, mostly students, dead.

These types of incidents are becoming the "norm," and that's

#### not acceptable.

The answers which have been proposed are complicated in both theory and practice. Some have proposed stricter gun control measures, which proponent argue would prevent or reduce the likelihood of a tragedy such as that in Florida. Opponents of that plan say that guns are not to blame, often instead placing the bulk of the blame on mental health issues.

There are obvious strides we need to make in the area of ensuring mental health issues in our nation are dealt with in an effective way, but that's not likely to be the only answer either.

In fact, there's likely at least a dozen other realistic proposals, and it's perhaps a combination of all of them which will work toward reducing school shootings to a historical fact, not a current event.

Regardless of what the answer is, it's not likely to come tomorrow. And, unfortunately, that may be too late to prevent more senseless loss of life.

What can be done in the meantime, however, is that all responsible for the safety of our children - school district officials; law enforcement and first responders; even faculty and staff at our local schools - must

begin preparing for and educating themselves on what to do in the worst-case scenarios.

After all, in the moments in any kind of violent incident, those "on the ground" at the school level will be dealing with the incident hands-on, potentially defusing, and definitely dealing with the aftermath.

In addition to learning how to deal with the worst-case scenario, however, these officials must also learn to prevent these kinds of incidents. That means learning to identify and deal with those who are potential threats to the student body and being aware and prepared.

School districts must support these efforts at the school level and empower teachers and staff to act without having to wade through red tape that sometimes costs too much time, especially in the case of a threat. These same members of school faculty and staff must also identify where they can prevent and stem bullying and other types of violence on school grounds and beyond, so that they can de-escalate before a situation turns to violence.

There's no easy answer, but by coming together now and working to prevent incidents, we can begin to avert tragedy.

him not being retained as assistant principal for the high school. May was the boys' basketball coach at Pike Central for two seasons, 2014-15 and 2015-16, before the hiring of nowhead coach Ryan Whitaker in the summer of 2016. May served as assistant principal at the school through the 2016-17 school year and was informed he would not be retained in May 2017. He now serves as an Algebra teacher at Belfry High School.

In his complaint, May, through local attorney Larry Webster, alleged that, while assistant principal, he "observed, brought to the attention of co-employees, and to the superintendent of schools, various violations of the Bylaws of KHSAA including Bylaws relative to improper games, dead period violations, eligibility rules for players, recruiting violations, school attendance policy violations and other violations of the regulations of the KH-SAA.

KHSAA officials said no action has been taken because no official complaint of allegations has been received, with the exception of one sworn statement by one third-party parent of a Floyd County student, which is not part of an open case.

#### Allegations detailed

In October, May was deposed by Pike County Schools Board of Education Board Attorney Neal Smith, representing the defendant Pike County Board of Education. During the deposition, May detailed his allegations of recruiting and reporting violations which occurred while he was the head coach and following his non-retainment.

According to May, Clevenger is allowed onto the school property despite previous questioning by teachers about his role at the school. Clevenger is not an employee of the school or he was contacted about the student being recruited to the school. May called contacts he had at Mingo Central and "was given some stories about some things that happened there."

"I confronted Mr. (David) Clevenger about it and his comment to me was, 'The least you know about it, the better off you are,'" May said in his deposition. "I did inform ... (former principal David Rowe) at that time that I suspected ... the kid ... was illegal."

Things escalated from there, according to May's deposition.

"(Student 1's) uncle came to me probably a week, week and a half, into practice and ... said, 'We need to talk.' I won't forget it. It was a drizzly day out back of the gym. I said, 'Okay.' He said, 'No, let's go to your coaching office," May said in the deposition. "So we went in there and his first comment to me was, 'Where's our car at?' I said, 'What do you mean ... I don't know what Dave (Clevenger) has promised you, but I don't play that way."

May said the student remained at Pike Central for the next three or four days before he left the school, "without withdrawing or anything."

According to May's deposition, he cited his inquiry into Student 1's alleged recruitment as one of the reasons he was not retained. May said his concerns with the alleged recruitment played a "big role in it, yes, because I wouldn't keep the kid."

### May: Questions led to employment changes

He received a letter detailing his non-renewal on April 1, 2016, according to the complaint and May's deposition, which is a standard procedure for high school coaches who coach on a one-year retainer and are evaluated following the season. The coaches, typically, receive letters of hire sometime soon after the first. May did not, he said, and his former job was posted to the KHSAA website by April 12. So, he said, he sought out Rowe and Pike Central Athletic Director Eugene Lyons about why he was not being asked back. He first approached Lyons, who, according to May, said he was doing "what his boss told him" and declined to say which "boss" had told him. Rowe, likewise, according to May, stated he was "doing what he was told to do," without elaborating further. Rowe did tell May he could re-apply for the position, according to the deposition, but following a meeting of the Pike Central Site-Based Decision Making Council (SBDM), the school decided to hire Whitaker. Admittedly without evidence, May said in the deposition he spoke with members of the SBDM, who told him they also were doing as they were told. Smith questioned May about any evidence he had to back the claim up, but, he said, "They are not going to talk because they are afraid of retaliation." Despite the loss of the position as basketball coach, May remained at the school as an assistant principal. But, on May 4, 2017, he received a letter that he would not be retained in that position, resulting in a musical chairs of sorts where he was first named as a classroom instructor for Northpoint Academy, for one week, before heading to teach math at Belfry.

he said he reported to Taylor. Earlier in the deposition, Smith asked a similar question and May answered that he believed it was because he "questioned" some of the kids being brought to the school by Clevenger.

#### Student 2 arrives

The first encounter in his role as assistant principal, according to May, was questions surrounding the 2016 arrival and living arrangements of a international student we will refer to as Student 2. Student 2's arrival preceded the arrivals of Student 3 and Student 4, another international student.

May said that, when Clevenger brought the students, May, in his role as assistant principal, began to receive calls with complaints. During the summer of 2016, Rowe had retired and the school brought Phillip Birchfield in on an interim basis until the SBDM decided on hiring Taylor to the position of principal.

In July 2016, during the KHSAA dead period, May said in the deposition, he was helping to go through a new camera system which had been installed at the school when he noticed at least one camera in the gym was not working.

"I walked down to the gym and found out they were taped up," May said.

According to May, he reviewed the film and reported to Rowe that Whitaker, Student 2, Lyons and Clevenger had been in the gym. May said that, on the film, the three adults had the student climb and put tape over the top of the cameras. May said he was told "we couldn't take some kind of CD and do it with the new camera," so he took pictures of the stillframes and provided those in his report.

"I had several coaches in the area calling and saying, ... 'These kids are illegal ... we are going to report you." I thought, as administrator, it's my job to make sure the school is not going to be punished along with the county athletics," May said in his has called me back again.' I said, 'Here is his number.' (Adkins) took the number and said, 'I will take care of this,'" May said. "That's pretty much the last I kind of dealt with that issue."

But it was not the last issue to arise in reference to Student 2.

What happened next, May said in the deposition, is what he believes one of the reasons he was not retained as assistant principal. There was an incident later in the school year, near March, when Student 2 visited May in his office.

"(He) came to my office ... and asked if I could get him out of the Clevenger's house," May said in the depositions. "I told him I would try to do what I could, but I was told not to deal with any kids in the sports at Pike Central, and that I would report it to the next proper authority which was with Mr. Taylor. It was a couple of days later the kid refused to go back to the house. Mr. Taylor ended up calling Social Services."

### May alleges he was told to 'stay out of sports'

May said in the deposition that, in reference to previous reports with two other students (Student 3 and Student 4), Taylor had told May "to stay out of it because it was dealing with sports" and "not to deal with anything dealing with any kids with sports."

Smith questioned May about what he reported to Taylor and May said he reported "That this kid did not want to go back to the Clevenger's house, that he come in, said he was hungry, they don't have much to eat."

Student 3 arrived at Pike Central, but, according to the deposition, after a few months, the student "got in more trouble, so Clevenger sent him back to somewhere in New York." Another family at Brushy, according to May, brought Student 3 back to Pike County and attempted to enroll him at Pike Central, but were denied.

May said Student 4 was the one player he got "a ma-

10th grader in St. Louis, was reclassified and played as a 10th grader at Galilean, played seven games last season at Pike Central and is now playing at Pike Central this season.

According to May, when he was alerted to that information, he approached Pike Central Guidance Counselor Heather Birchfield to bring it to her attention.

Heather Birchfield called the school, received additional paperwork and then reclassified Student 4 as a junior, May said. That incident occurred in late January, early February 2017, May said.

#### May claims other violations reported

May said he reported other violations to Taylor, which Taylor handled, in an effort to save the school money for which, May claimed, the boys basketball program would have been responsible.

That included being 22 games late on statistics reporting during this past basketball season. The KHSAA imposes a \$100 fine for any stats not reported within 72 hours of completion of a contest.

May said in the deposition that he alerted Taylor that they may be responsible for \$2,200 in fines, because the stats were reported and put onto the KHSAA website, May said. Additionally, May reported that Whitaker and an assistant coach had not completed a safety and rules clinic during the previous basketball season. May said that, when he learned of the failure to complete the mandatory sessions, he knew Whitaker would be ineligible to coach in postseason play and alerted Taylor so the coaches could get it done. Whitaker and his assistant completed the clinic in time, but the school had to pay a late fee.

May also referenced the fact Clevenger would host tournaments, including tournaments with regional high school players, on the campuses at Pike Central and Mullins. According to a letter had ever reported the violations to the KHSAA.

"So you have never snitched or called KHSAA and said, 'Hey, they are doing this. They are doing that. You need to come up here?" Smith asked.

May said that he had not, "as much as I wanted to ... I'm not going to do that."

"There's too many good people there and there's too many good kids to punish the whole school for what a few adults are doing," May said.

The board of education, for its part, denied each allegation of reprisal by May. In addition, the board filed a counterclaim saying that May had, inadvertently, been paid more than \$7,500 for school year 2016-17 after the school district's payroll department continued to pay him as head basketball coach for that season. May said he did not deny that allegation and said he had not paid attention to his pay stubs, so Smith said he had a signed affidavit from Director of Finance Nancy S. Ratliff about May being overpaid.

That affidavit, though, does not state that May was overpaid for the 2016-17 school year. The affidavit, which was signed and attested to by Ratliff, states, in part, that "due to an inadvertent error in the payroll department," May received checks paying him for the basketball position in the 2015-16 school year, when he was, in fact, the coach of the boys basketball program.

Smith also stated during questioning that, with the school district, "Sometimes payroll misses these letters that come across their desk and they don't realize what they have done at Pike Central."

Case continues to move through system

As part of the case, in December, Webster filed a request for productions of documents, asking for, among others, documents related to the SBDM in relation to the non-renewal of May as assistant principal. In relation to documents showing Taylor being notified Superintendent Reed Adkins and Personnel Director Danny Adkins of funds available for Pike Central resulting in two non-tenured certified employees, including May, to not be renewed, the board responded the notification from the central office was "verbal." The board responded the communications of determination by the SBDM to Reed Adkins was also "verbal." Webster requested any correspondence "from any other schools, board of education or regulatory bodies relative" to the four individual student athletes. The board said the "documentation is not readily available and will be supplemented as soon as possible" in its response dated Jan. 4, 2018, but, those documents have yet to be produced and have not been included in the case file. Webster said, as of Wednesday, those documents had yet to be produced. Reed Adkins was set to be deposed in the case by Webster on Jan. 19, but that deposition was canceled, according to Webster. Another deposition for Adkins will be scheduled in the case, Webster said. Following the canceling of the deposition for Adkins, Smith filed a "Motion for Summary Judgement" against May for the payroll error and that his case of reprisals be dismissed, which included filing the aforementioned affidavit from Ratliff as evidence in the summary judgement, court documents show. The case is set for motion hour in front of Pike Circuit Judge Eddy Coleman at 1:30 p.m on Friday, Feb, 23.

the school district, but his wife does work as a cook at Pike Central, according to May's deposition.

May said that while he was coach, Clevenger would attend nearly 90 percent of practices. May said he called Assistant Superintendent Freddie Bowling about Clevenger being at the school and "he said he was going to take care of it," but that, "Clevenger was on campus pretty much every day from that point on."

"That's when (current Pike Central Principal Steven Taylor) came back about a week or two later and told me that (Clevenger) was just considered a good booster for the school," May said. May quoted Taylor as referring to Clevenger as a "good booster."

According to filings with KHSAA, Pike Central High School did formerly have a booster club on record for the football program, but no booster club has ever been registered for the Pike Central basketball programs.

According to KHSAA Bylaw 16, booster club parents and members and booster club representatives are considered school representatives. Bylaw 16 reads that, if impermissible recruiting is suspected, "a coach or staff member (paid or unpaid) should immediately refer the person(s) to the school principal."

#### Questions arise about 'Student 1'

In 2015, a former Mingo Central (West Virginia) High School student, referred to in this report as Student 1, enrolled in Pike Central High School with intentions including playing basketball for the school. According to May, when Student 1 arrived, Smith asked May if he "had any notion ... why (Superintendent) Reed Adkins would not bring you back as an assistant principal?" May replied that, in his opinion, it was because he had "try to do things the right way" referencing rules violations

t deposition.

Student 2, according to May and a letter obtained by the News-Express, was supposed to be enrolled at a prep school in Gary, Indiana, called Lighthouse College Prep Academy. The school sent a later to then-Principal Rowe on Aug. 11, 2016, detailing that the student was on a F-1 class visa admission for academic and language purposes.

According to May and the letter, Clevenger intercepted Student 2 at Chicago's O'Hare International Airport. The customs agent who received the student upon his arrival placed him in a lobby in the airport to await a doctor with whom he was to be living in Indiana, the letter said. When the doctor and school officials arrived at the airport, they searched for Student 2 for several hours, which included help from the Chicago Police Department, the letter said. The doctor filed a missing persons report, and after two months of searching for Student 2, according to the letter, he was located at Pike Central through social media.

A search of the U.S. Dept. of Justice's National Missing and Unidentified Persons System shows no filings in Kentucky, Indiana or Illinois that references any iteration or combination of the student's name.

The school then sent the letter, but, due to the dating, there remains questions about who at the school in fact ever received or saw the letter. May had received "numerous" calls from the "principal" at Lighthouse, he said.

"He called me numerous times and one day actually called and Mr. (Reed) Adkins was in Mr. Taylor's office, and I told him. I said, 'This guy

jority or a lot of calls on from several coaches."

Student 4 arrived as a transfer from Galilean Christian Academy in Liberty, Kentucky, after playing there for at least one season, in addition to two seasons at St. Louis Christian Academy in Missouri and one year at a prep school in Dallas. According to May, when Student 4 went from Dallas, Texas, to St. Louis, Missouri, he was reclassified as a freshman, played two seasons and went to Galilean, where he was reclassified as a sophomore.

On Feb. 5, the official website of the government of Student 4's home territory issued a statement and congratulated Student 4 for his successes on the basketball court and in the classroom. But, included in the statement was the revelation that Student 4 also attended a high school in the territory before he "transferred to the United States to pursue his basketball dreams."

When he arrived at Pike Central from Galilean in the 2016-17 school year, Student 4 was enrolled into the school as a sophomore based on the records received from Galilean, May said.

Appalachian Newspapers sent a reporter, Trevor Thacker, to speak with Galilean coaches at a contest this season.

An assistant coach joked to Thacker, after Thacker identified himself, that Student 4 "should have graduated a while ago." But, when Thacker began to ask questions, the coach went into the locker room and closed the door.

According to May, the student spent a ninth grade season in Texas, was reclassified and played two years as a ninth grader and provided by an official with the Floyd County Schools District, a 2017 tournament was the site of Clevenger attempting to recruit a Floyd County basketball player.

The parent wrote that, on April 8, 2017, her son, along with friends from the former South Floyd and Allen Central high schools, attended a tournament hosted by Clevenger at the Pike Central gym. While there, the parent wrote, Clevenger approached her to "ask me what it would take to get (her son) to come play at Pike County Central the upcoming season." The parent reported she told Clevenger there was "no way" she could drive to Pikeville every day and "could not afford to live in Pike County." Clevenger, according to the letter to KHSAA, stated, "I know a place that you can stay at and you wouldn't have to pay anything to live there for free."

The parent told Clevenger she worked for the Floyd County Schools District, to which, she wrote, Clevenger replied "well, there might even be a job to go alone (sic) with the house." Clevenger said if the student were to come to Pike Central, "the regional title would belong to Pike County Central."

# **Beshear sues Cardinal Health for massive** shipments of prescription painkillers Distributor's deliberate actions created public health hazard, violated Kentucky law

Kentucky Attorney General Andy Beshear has filed a lawsuit against one of the nation's leading opioid distributors Monday for its alleged role role in fueling the state's opioid epidemic by funneling massive amounts of prescription opioids into Kentucky's communities.

In his third opioid lawsuit to date, according to a statement from Beshear's office, Beshear is suing Ohio-based Cardinal Health over unfair, misleading and deceptive business practices for excessively distributing opioids, particularly in rural counties in Eastern Kentucky, and for failing to report the suspiciously large volume of these drugs to state and federal authorities.

Beshear filed suit Jan. 22 against another opioid distributor, San Francisco-based McKesson Corporation, for similar claims. Beshear filed his first suit in Nov. 2017 against Endo Pharmaceuticals and Endo Health filed in Jefferson Circuit Solutions for violating

contributing to state opioid related deaths and overdoses from its drug Opana.

"I'm committed to hauling each of these opioid companies into a Kentucky court to answer for their actions that have devastated our families, communities and state," Beshear said. "The authority to hold these companies accountable for both their damages to our state and our people lies with the Attorney General, and I plan to use this authority to seek justice for Kentucky families."

Along with AmerisourceBergen, McKesson Health and Cardinal Health distribute 85 percent of the nation's drugs.

According to Cardinal Health's second-quarter results for fiscal year 2018, revenue for its pharmaceutical segment increased 5 percent to \$31.1 billion just for the quarter due to sales growth from pharmaceutical and specialty distribution customers.

Beshear's lawsuit, Court, alleges Cardinal

state law and directly Health reaped "a windfall off of the wave of addiction" in Kentucky by choosing profits over people while abrogating its duty to report suspiciously large orders of controlled substances, including opioids, to state and federal law enforcement as required by federal and state laws.

Cardinal Health has admitted failing to meet its reporting duties in the past. For example, in 2016, the company reached a nationwide \$44 million settlement for "failure to detect and report suspicious orders of controlled substances."

In 2017, Cardinal profited from a 20.7 percent market share, the third highest in the industry.

From Feb. 1, 2016 to Jan. 31, 2017, Kentucky pharmacies filled 307.2 million doses of opioids, which breaks down to 69 doses for every man, woman and child in Kentucky. Pursuant to its market share, Cardinal Health distributed 63.6 million of those doses of prescription opioids.

From Jan. 1, 2010 through Dec. 31, 2016,

Cardinal Health distributed 1,186,418 doses of prescription opioids in Jefferson County alone. Based on Jefferson County's average population of 755,305, it amounts to 1.5 opioid doses for every man, woman and child living in the county. Beshear said Cardinal

Health carelessly flooded other Kentucky counties with high volumes of prescription opioids during this period as well.

• In Floyd County, based upon its market share Cardinal Health distributed approximately 11,669,757 doses of prescription opioids. Based on Floyd County's average population of 38,638, it amounts to 302 doses al have current lawsuits for every citizen.

• In Clay County, based upon its market share Cardinal Health distributed approximately 5,263,988 doses of prescription opioids. Based on Clay County's average population of 21,407, it amounts to 245 doses for every citizen.

• In Bell County, based upon its market share Cardinal Health distributed approximately 6,228,977 doses of pre-

scription opioids. Based on Bell County's average population of 27,961, it amounts to 222 doses for every citizen.

From 2012 through 2016, more than 1,250 Kentuckians died from opioid overdoses in these four Kentucky counties. Statewide, for this timeframe, Kentucky experienced more than 5,800 fatal overdoses.

Beshear's lawsuit against Cardinal Health is just one of hundreds filed across the nation. According to a recent report by the company, as of Feb. 2, 2018, the company has been named in 343 lawsuits.

Two attorneys generagainst Cardinal Health -Delaware and New Mexico.

West Virginia Attorney General Patrick Morrisey settled a lawsuit against Cardinal Health for \$20 million.

Beshear is working with AG Morrisey and Ohio AG Mike DeWine to find solutions to the drug crisis in their region of the country.

In Dec. 2017, all federal lawsuits against Cardinal Health, 298 as of Feb. 2, 2018, were ordered transferred for consolidating pre-trail proceedings in a multistate litigation proceedings by U.S. District Judge Dan Polster for the Northern District of Ohio.

Beshear joined AG DeWine, Tennessee AG Herbert Slatery and several other AGs in Cleveland Jan. 31 to represent Kentucky in front of Judge Polster in national prescription opiate litigation talks.

Beshear said the federal judge wanted to hear how pharmaceutical companies and distributors, many who were in the courtroom Jan. 31, have harmed Kentucky families and communities.

"Kentucky has lost so much," Beshear said. "But a better future is possible. The companies that made billions have a duty to help us create a future. They have a duty to fully fund treatment, prevention, recovery and enforcement efforts."

# Allen pastor to be nominated for KBC presidency

Appalachian pastor Tim Searcy, who has a broad range of ministry experience that includes international missions and Christian higher education, will be nominated to become the next president of the Kentucky Baptist Convention.

Fitzpatrick First Baptist Church Pastor Tommy Reed said he intends to nominate Searcy, pastor of Allen Baptist Church outside Prestonsburg, at KBC's annual meeting in nearby Pikeville in November.

Searcy said he would accept the nomination.

"The Lord has taken this man all over the world to share the gospel," Reed said. "He has a vast knowledge that crosses so many

bounds. He could do whatever he wants to do, but he chose to come to the mountains to serve as pastor. He is not living his life

for himself; he is living it for Him." Searcy has a Ph.D. in Christian education from New Orleans Baptist Theological Seminary, where he also received his educational doctorate and master's degree in religious education. He also has bachelor's degrees from Lincoln Memorial University and Clear Creek Baptist Bible College. His affiliation with Baptist institutions date back to his teenage years, having graduated high school from Oneida Baptist Institute in southeastern Kentucky.

The church Searcy has served the past three years gives approximately 1.5 percent of its undesignated receipts through the Cooperative Program. Last year, the church gave \$4,200 from undesignated receipts totaling \$290,000, according to Southern Baptist Convention records. The church gave approximately \$7,000 more through KBC and SBC missions offerings. Total Great Commission giving, Searcy said, totaled \$27,874 or 9.6 percent, last year. That includes mission trips by his church to Brazil and Swaziland.

Allen Baptist's average worship attendance for the past three years ranged from 220 to 230. The church reported 69 baptisms since Searcy arrived at Allen three years ago.

In ministry since 1975, Searcy has served as a youth minister, minister of music, associate pastor, pastor, missionary and church planter. He began teaching at New Orleans Baptist Theological Seminary as an adjunct member of the faculty in 1989. Since then, he has served as vice president for academic affairs at Louisiana College, director of institutional effectiveness at Clear Creek Baptist Bible College, associate director of the professional doctoral program at New Orleans Baptist Theological Seminary, followed by stints as director of doctoral education programs and director of institutional effectiveness for the seminary.

As pastor, Searcy served churches in Kentucky and Mississippi. He also has served as interim pastor in multiple churches in Kentucky and Louisiana. He planted Vida Nueva Baptist Church in Colombia while serving as a missionary.

Besides Colombia, Searcy has done mission work in Brazil, Costa Rica, Colombia, Russia, Nicaragua, Nepal, Cambodia and Cuba. His work in Cuba was with the Baptist Seminary in Havana assisting in training of teachers and developing curriculum.

"I know the kind of man Tim Searcy is," Reed said. "He's so personable. He's very approachable. You would never know he has a 'Dr.' in front of his name just from talking with him. He's an 'every man.' He can relate to those in the mountains and the hollows of eastern Kentucky. He can relate to the people in the realms of higher education. He can relate to people in the slums of New Orleans or the jungles of Columbia or the monks of Nepal. I just think, from Paducah to Pikeville, from Williamsburg to Covington, he can relate to any part of the state."
