Prestonsburg officially signs lease on amphitheater

A ceremony was held Friday at the Jenny Wiley State Resort Park Amphitheater to signify the official

signing of a lease between the state and the City of Prestonsburg

"When they found the maintenance issues and they sort of closed down the theatre, I immediately ... started to reach out," said Prestonsburg Mayor Les Stapleton.

Stapleton said the city could not afford to lose the

Recanvass to be held this week

Floyd County Clerk Chris Waugh will conduct a recanvass of votes requested by at least three candidates this week.

Candidates have until 4 p.m. on Tuesday, May 29, to request a recanvass of votes cast in the primary election, and, as of print deadline, three of them had done so.

As of print deadline Tuesday, written recanvass requests had been submitted to the county by Warren Jarrell, who lost the District 3 magistrate's race by five votes to incumbent Mike Tackett, and Floyd County Judge-Executive Ben Hale, who lost that race by 31 votes to James "Jimmy" Rose.

Gene Smallwood Jr., who was appointed to the Court of Appeals in January, also requested a recanvass of the Court of Appeals race with the Kentucky Secretary of State. Smallwood received 17,705 votes in the 22 counties represented in that race, and was well behind the top two contenders, David Allen Barber of Morehead who received 22,744 votes and Larry

sentenced to 12 years in prison in Floyd pill case

Final defendant

A Floyd man who, prosecutors say, led a "family business" that turned "Abner Mountain into a convenience store for controlled substances" was sentenced to 12 years in prison Thursday in U.S. District Court in Pikeville.

The sentencing of Jeffrey Isaac, 61, of Melvin and Detroit, Michigan, closed out the case against Isaac, his wife Karen Isaac, 45, his daughter Alyssa Isaac, 21, and Alyssa's boyfriend Scotty Tackett, 39, as the four have now been sentenced for their roles in the trafficking ring.

During Karen and Alyssa Isaac's sentencing, Chief U.S. District Judge Karen Caldwell termed the Isaac/Tackett ring as "if ever, truly, there was a family business, this is the one."

In June 2016, controlled purchases were made from both Karen and Alyssa Isaac, before U.S. Marshals sought and executed a search warrant at their residence, the plea agreement in the case said. During the execution of the search warrant, law enforcement officials located more than 1,500 prescription pills at the residence; including 481 Neurontin and 440 Xanax, well as quantities as See SENTENCED, Page 6A

Man faces charges after allegedly trying to sneak drugs into jail

A man is facing drug trafficking charges after allegedly sneaking drugs into a police vehicle after being arrested.

Henry Frank Landon, 30, of Paintsville, was arrested and charged with three counts of first-degree trafficking in a controlled substance for a variety of different drugs, according to his arrest citation.

According to the citation, last Wednesday deputies with the Floyd County Sheriff's Office responded to a complaint of a vehicle located in the Garrett Park area that appeared to have four individuals in it that were allegedly under the influence.

Upon locating the vehicle, deputies allegedly observed London walking off of a basketball court towards the vehicle and drop a item on the ground. London then allegedly entered into the vehicle's passenger side.

According to the citation, upon making contact with the occupants, deputies observed London attempting to reach between the seat and his pockets several times.

The citation said that deputies asked London to keep his hands in plain view, but he would not comply.

London and the driver of the vehicle were both detained for appearing to be under the influence and for officer safety, according to the citation.

London was placed into the back of one of the deputies vehicles while the area was searched where London allegedly had dropped something near the basketball court.

After searching the area, the deputies allegedly found a

small bag full of a white substance that they believed to be cocaine.

Inside the vehicle, according to the citation, the deputies found a black container with several empty plastic baggies and scales.

While en route to the jail, deputies alleged that London was moving around in the back suspiciously.

According to the citation, London was removed from the vehicle and searched again where a large sum of cash was found inside of his underwear and socks, and a small bag containing Opana, Xanax, hydrocodone, oxycodone and methadone was found in the back seat.

London was then transported to the Floyd County Jail.

A preliminary hearing was held on May 25 where Judge Eric Hall set a \$10,000 cash bond in the case, according to court documents.

Man facing meth charges after traffic stop

A man is facing drug and tampering with evidence charges after officers allegedly found drugs in his vehicle during a traffic stop.

Ricky Randy Lewis, 43, of David was arrested and charged with first-degree first-offense trafficking in a controlled substance (methamphetamine), tampering with physical evidence and possession of drug paraphernalia.

According to the arrest citation, Prestonsburg Police responded to a complaint last week of an impaired driver in a Marathon parking lot.

Officers then conducted a traffic stop on the vehicle, where they allegedly determined Lewis to be impaired. After placing Lewis in the back of a police vehicle, the citation said, the officers noticed a container beside the vehicle that wasn't there previously.

Officers said in the citation they found a large amount of a crystal-like substance inside the vehicle, which they believed to be meth. Inside the vehicle, the citation said, officers located a syringe, scale and a large amount of cash.

Lewis was then arrested and transported to the Floyd County Jail.

A preliminary hearing for the case was held on May 25, where Judge Eric Hall set a \$5,000 cash bond in the case, according to court documents.

Court documents said Lewis pleaded not guilty to the charges.

Man indicted in alleged hit and run

A man has been indicted for his role in a July 2017 crash, when he allegedly fled the scene of the crash and failed to render aid to a victim.

Kyle Collins, 23, of Berea, was indicted by the Floyd County Grand Jury last week on a charge of leaving the scene of an accident (failure to render aid or assistance).

The indictment alleges Collins is responsible for the death of a pedestrian, when he knew or should have known that the pedestrian suffered serious physical injury.

"In this case, the allegation is that the victim and another man were walking beside the road and the car struck the victim, killed him and it didn't stop and went on," said Floyd Commonwealth's Attorney Brent Turner.

According to Turner, the witness was unable to give detectives a clear description of the vehicle, but many months later an abandoned vehicle was found by Kentucky State Police detectives. The vehicle was believed to be involved in the hit and run.

"That provided the information that state police needed to take the investigation in the direction that led ultimately to the indictment," said Turner.

According to court documents, an arraignment has been scheduled for June 22.

Library starts summer reading program

The Floyd County Public Library is launching its summer reading program this month.

Themed "Libraries Rock," the month-long program allows patrons of the library's branches in Prestonsburg and Eastern to read books to be entered into a random drawing for musical instruments that will be given away. Every time a child check out a book, he or she is entered to win a guitar, ukulele, or keyboard which will be given away during the summer reading program grand finale, which will be held at Eastern at the end of the month.

Children who participate

in the summer reading program will enjoy several music-themed events, like the June 1 sock hop that will be held at the Eastern Branch, a "disco magic show" that will be held on June 7 at both locations, the "Catch a Sound Wave" science experiment with the East Kentucky Science Center on June 12 at both locations; visits from Pete the Cat on June 14-15, and workshops on June 20-21 in which children will learn how to make their own instruments at both locations.

The Kentucky Historical Society will be visiting the Floyd County Library on Tuesday, June 26, at 2 p.m. in Eastern and 5 p.m. in Prestonsburg to host "Bluegrass Music: A Kentucky Tradition." In this event, young students will work with their parents to create a song and music video using costumes provided by the historical society, while older students will use iPads to mix music and create songs based on their family's "Kentucky story." Both student groups will play the "canjo," and washboard, and they will also create their own harmonicas.

The Eastern branch will celebrate the end of the summer reading program on June 29 from 2 p.m. 4 p.m. with water inflatables, snow cones and activities, but that's not the end of the music-theme summer of activities. The Prestonsburg branch will continue hosting "Libraries Rock-themed events through July, hosting evening workshops and activities open to participants of all ages.

Its schedule includes a Libraries Rock trivia game at 7 p.m. on June 28, a line dancing program on July 6, a workshop on Christian rock music on July 12, a square dance on July 20, and, following the Battle of the Bands competition, a workshop on "The invasion, Motown and Pop Music" on July 26.

To celebrate the "Libraries Rock" theme, the Prestonsburg branch is accepting applications for the first-ever Libraries Rock Battle of the Bands competition, which is set to be held July 21 in Prestonsburg. Applications, available on the branch's Facebook page, are being accepted through July 9.

In June, the Floyd County Public Library is also hosting an outreach program for the Libraries Rock Summer Reading program, in partnership with the Floyd County School District, to host programs at Cliffside Apartments, Dixie-Highland Heights, Green Acres, Maytown Center, Warco Apartments, Ivy Creek Apartments and the Left Beaver Creek Apartments.

Floyd County Fire School set for this weekend

For the first time, the Floyd County Firefighter's Association is hosting a regional "Fire School."

Association president Grady Allen said officials have been trying for at least five years to get a regional fire school set up in Floyd County. Local fire schools — multi-day events that provide classroom instruction and hands-on training for firefighters and first responders - are usually held in Pike and Johnson counties. Allen said participation fell in Johnson County last year, so officials decided to bring that fire school to Floyd County. Allen has worked with oth-

er association members since November to plan the event for the state fire and rescue training area 11, which covers Floyd and surrounding counties. It was originally planned to be held in April, but was postponed because of inclement weather.

Admission is free for the fire school, which will be held June 1-3 and is open to firefighters from across the state. Allen said more than 200 firefighters have already registered and officials stopped taking registration for this event, but classes are still open and people can register on site this

weekend.

The association is providing snacks and refreshments for participants and Friday evening, and event sponsors Air Evac, Public Safety Store of Lexington and Air Methods, are sponsoring meals on Saturday and Sunday.

Air Evac and the Public Safety Store are also hosting a competition for firefighters, which will be held at the Air Evac Lifeteam base on Stonecrest on Saturday. That competition will feature several contests, including "Rescue Jenga," and awards will be presented. Allen said it will likely start at around 6 p.m.

Classes that will be offered

during the fire school include several two-day courses on rural water supply, basic and advanced firefighting skills, vehicle extrication and ATV safety and rescue, among others.

Allen said the ATV course, being held as a joint effort between the Kentucky Fire Commission and the Kentucky Department of Agriculture, will show participants skills they can use to rescue ATV wreck victims, as well as skills they can use while riding ATVs or UTVs. Participants are bringing their own ATVs to this course.

Allen said there will be live fire trainings outside on the college campus as well.

The National Fire Academy

is also sponsoring a Leadership in Supervision Class, to help fire departments learn more about creating an environment for professional growth. A three-day continuing education course for emergency medical technicians will also be provided, allowing participants to receive 20 hours of credit for training-half of what they need to have each year.

Firefighters who complete these classes will receive certificates for their work.

EDITORIAL:

Voter turnout matters

Congratulations, candidates. The 2018 primary election is behind you.

A few of the victorious will continue your campaigns with opponents you face this fall, but the majority of you now have plenty of time to start planning your transition into your new role.

Regardless of what was said on the campaign trail, we hope you take that task seriously while holding onto what's best for all Floyd County residents. Those of you who do not face opponents this fall are no longer candidates. It's now time to get real and get to work on moving Floyd County forward.

If we've learned anything about elections in this campaign season, it's that voter turnout matters.

The Democratic candidate for judge-executive was selected by only 31 votes, while 52 votes made the difference in the District 2 magistrate race, and the race for District 3 magistrate was determined by only five votes. The District 2 constable race was also close, with 72 votes between the long-term incumbent and the newcomer.

There were 30,254 people registered to vote in Floyd County, and 11,294 of them cast their ballots in the primary election. That means 37.33 percent of the county's registered voters actually determined who won these races. That's much higher than the state's voter turnout of 23.54 percent, but it still is far behind what it should have been.

The county's turnout percentage would have been the same, in other words, if we placed 100 Floyd County voters in a room and asked them to pick the best candidates for the job, and 37 of them took us up on that offer. Thirty-seven out of 100 is a failing grade in school.

We thank the 11,294 voters in Floyd County who made sure their voice was heard in the primary election. We encourage those who, for whatever reason, didn't take the time to vote to ask themselves why.

Primary over, time to pick up signs

Alright, folks, the primary election is over, where are your signs?

With the primary election behind us, and the winners and not-so-happy losers wiping their hands of all the campaigning fanfare, we'd like to remind all candidates seeking office to please remove your campaign signs.

If you, or one or two, or 80, of your campaign workers hammered, glued, screwed or attached signs on telephone poles, on existing road signs, near state and county road right-of-way areas, intersections or thereabouts, please come remove them, pull them up or take them down, so we don't have to look at them anymore. Please remove them so our tourists won't see them either.

Don't get us wrong, we love campaigns, and we congratulate winners of each and every race held in Floyd County.

We just don't want to have to look at these signs until the next election, and we certainly don't want to have to watch them wither away because they're left neglected out there in the weather.

Do them, and us, a favor. Please remove your signs. Save them for next time.

Tax hike, not teachers, will sink GOP this fall

The Associated Press is sticking hard to its narrative that Kentucky's November Legislative elections will be about the Republican pension reform bill.

The news service chronicled the defeat of State Rep. Jonathan Shell in Tuesday's Republican primary. Shell was recently installed as House majority leader after a sexual harassment claim felled longtime Republican leader Jeff Hoover from the job.

Shell lost to Travis Brenda, a high school math teacher. The AP says that "voters turned on Shell for his role in writing a new state law that moved all future teachers into a hybrid pension system."

incumbents in GOP primaries all lost, but said Shell "was the only one ... to vote for the pension bill." No disrespect to teachers, but unless you are one, we don't think as a voter you are exorcised about a change to teacher pensions that mostly affects future hires.

All politics is local as they say and Brenda can be forgiven if he takes offense at the suggestion he won simply because he is a teacher. We suspect if legitimate exit polling had been done one would find a larger source of discontent among Republican voting challenges (in November), mostly as Democrats." We think this will prove the least of their concerns. The real reason Republicans should be scared is because beginning July 1 the people who voted for them last time (a population that we'll wager includes relatively few teachers) will begin to experience the breadth of the new services taxes they recently engineered.

The conservative Bluegrass Institute circulated a "News Alert" the day before Tuesday's election reminding its followers of the size and scope of this atrocity, which is exclusively the work of the GOP legislative supermajorities. The "alert" recites the many services Kentuckians will begin paying tax on July 1. Here is that list: labor and services for personal property (painting, mowing, etc.); dry cleaning and laundry services; uniform services; pet grooming; pet boarding; small animal veterinary services; fitness center memberships and services; non-medical weight loss center memberships and services; golf course and country club fees; extended warranties; landscaping services; overnight campground fees; limousine services; and bowling.

There also is a state income tax increase for businesses and

But Kentuckians who live outside the media echo chamber will recognize this for what it really is: a classic tax revolt, one from which Republicans will not soon recover.

We have our doubts about that.

Bald eagle returns to Pike after rehabilitation

Jefferson, a mature bald eagle, was released at Fishtrap Lake Saturday after being in the care of the Liberty Nature Center for a few months.

Community members and members of the Liberty Nature Center — a nonprofit organization based in Somerset that works with injured animals and offers education to communities across Kentucky - gathered near the boat dock at Fashtrap Lake to see the eagle being released back at his

home.

Frances Carter, CEO of the Liberty Nature Center, said she believes Jefferson is between four and five years old. The eagle was found injured in the Millard area in March. Carter said she did not believe Jefferson was going to survive.

"He had some severe injuries. He had lacerations to the chest area, a wing injury, puncture wounds to the left leg, his right leg was nonfunctioning and he was just really in bad shape," said Carter.

Carter said Jefferson visited five different veterinarians,

and their finding was that Jefferson was involved in an altercation with another eagle. The Liberty Nature Center was chosen because the center works with eagles regularly, Carter said.

The rehabilitation process for Jefferson included regular doses of pain medication and antibiotics, maintaining cleanliness of his wounds and providing him with a diet made up of fish, quail, rabbits and squirrel.

"After several weeks of this and that, (Jefferson) ended up losing a toe ... it had to be amputated, but everything else

- all of the other wounds healed up and we brought him back up here today to release him," said Carter.

Carter said that any time she is able to release animals back into the wild is a good experience. She said it was wonderful to see Jefferson return to his home after his rehabilitation.

"This is a happy time for us because he did survive and, honestly, I did not think he would," she said.

Eagles are becoming more prevalent in Eastern Kentucky, Carter said.

"The population is growing and it's really good to see that," she said. "It's something that people need to be aware of. They are in the area now ... You will see lots more of them as the years progress."

Carter suggests that people keep a towel or a blanket in their vehicle in case they find an injured eagle or other animal. She said to place the animal in a pet carrier and call the wildlife official closest to them.

14 names added to Kentucky **National Guard Memorial**

FRANKFORT - The Kentucky National Guard's annual Memorial Dav observance was held Monday at the Kentucky National Guard Memorial in Frankfort.

Fourteen names have been added to the Memorial, which honors Kentucky Guardsmen who died during active duty, bringing the number of names on the Memorial to 269 men and women since 1912. Of the new names being added, 13 died during World War I with the other from World War II.

Those added are:

· Captain John V. Bedinger, 32, of Anchorage, Jefferson County, died of pneumonia in Liverpool, England, Oct. 20, 1918, while on federal active duty with the 151st Field Hospital, 113th Sanitary Train, 38th Division.

Private First Class Emet Thomas.

Bingham, 22, of South Hill, Butler County, was killed in action in France July 28, 1918, while serving with Company E, 165th Infantry Regiment, 83rd Infantry Brigade, 42nd "Rainbow" Division.

• Private Charles J. Burckle, 27, of Louisville, Jefferson County, was killed in action in France Aug. 8, 1918, while serving with Battery A of the 146th Field Artillery, 41st Division.

D. Hammonds, 39, of Somerset, Pulaski County, died Feb. 5, 1945, of non-battle related causes while serving with Service Company, 149th Infantry Regiment, 38th Infantry Division in the Philippines.

• Private Herman Hancock, 36, of Lexington, Fayette County died Feb. 28, 1917, of Pneumonia due to exposure while on federal active duty at a demobilization camp at Fort

• Sergeant Joseph H. Holt, 28, of Paris, Bourbon County died of uremic poisoning due to kidney failure while on federal active duty at Booth's Memorial Hospital in Covington on or about April 17, 1917.

· Corporal Alvin J. Hoops, 24, of Wysox, Butler County, died April 19, 1918, of pneumonia while on federal active duty with his unit at Camp Shelby, Mississippi.

Thompson of Pike County, who received 19,159 votes.

Statewide, recanvasses must be held at 9 a.m. on May 31. Locally, the recanvass will take place in the Floyd County fiscal courtroom.

In a recanvass, officials go over the vote totals to ensure the numbers match what was reported on election night. The count ensures there were no clerical errors, and Waugh said he will also recount all absentee ballots by hand.

Jarrell was in the lead until those votes came in. At the time, Jarrell had 1,326 votes, while Tackett had 1,127. The Lee Hall precinct brought 311 votes in for this race, and the majority of them, 256, went to Tackett, giving him the five-vote lead over Jarrell, 1,383 to 1,378.

The report shows that 10,241 people voted in the judge-executive's race. Rose captured 19 precinct wins, followed by 15 precincts carried by Hale, who also had more absentee votes, and eight precincts car-

there except the John Ant/Frasure Creek precinct, which went to Hale by 29 votes. In this district, Rose gained 1,330 votes - the most received by any candidate in any district. That count is 550 more than Hale and 781 more than Lafferty in that district.

Hale won District 4 by 134 votes over Lafferty and 144 votes over Rose, carrying half of all precincts there, while Rose gained the lead in three precincts and Lafferty won two of them in District 4.

After a recanvass is requested and held, Waugh said candidates may also seek a re-count of the votes, which is conducted with oversight of a circuit judge.

Precinct reports provided by the clerk's office detail how voters selected candidates in each precinct.

The reports show that 2,865 people voted in the District 3 magistrate's race, with 1,383 votes for Tackett, 1,378 votes for Jarrell and 102 votes for candidate Ryan Slone. Tackett won five precincts in this district, and Jarrell, winning six of them, barely missed the win in the race. Tackett won the Clear Creek, Jacks Creek, Lee Hall, Melvin and Weeksbury precincts, while Jarrell won Martin, Halbert, Drift and the John Ant/Frasure Creek precincts.

The Lee Hall precinct carried the final votes to be counted in this race, and on election night,

ried by Bryan Lafferty.

Lafferty won District 1, his home district, winning six of 12 precincts there and gaining 14 more votes than Hale and 404 more votes than the lead in six District 1 precincts, but he walked away with 1,023 District 1 votes, compared to 1,037 votes earned by Lafferty. Rose did not win any precinct in District 1. His vote total there was over 400 behind the other candidates.

Rose and Hale, who both live in District 2, battled it out in precincts in that district. Rose walked away with wins at six of nine precincts in District 2, carrying with 83 votes more than Hale and 442 votes more than Lafferty. Rose and Hale both vote at the Middle Creek/Jack Allen precinct. There, Rose earned 153 votes and Hale received 121 votes.

Hale was defeated heavily in District 3, where Rose grew up. Rose won every precinct ty's biggest precincts - those with more than 1,000 registered voters per precinct — were split between all judge-executive candidates.

Rose carried two of Rose. Hale also gained them, Middle Creek/Jack Allen (by 32 votes over Hale) and Prater Creek, with six votes over Hale. Hale carried three of them, Cliff, by 51 votes over Rose; John Ant/Frasure Creek by 29 votes over Rose; and Betsy Layne by 17 votes over Rose. Lafferty carried two of them, Porter, by 17 votes over Hale; and Cow Creek, by 42 votes over Hale.

> On election night, the Lee Hall precinct in District 3 was the final precinct to report totals to the courthouse. The race was close at that time, with Hale in a 113-vote lead of 3,480 votes, followed by Rose with 3,367 votes, and Lafferty with 2,791 votes.

> The Lee Hall precinct brought in 308 votes in the judge-executive's race and most of them,

for the seat.

"I really do appreciate everyone that voted for me and supported me and believes in what I want to do," Rose said. "I'm not going to let them down. I'm the people's candidate, and I'm interested in helping our people."

If elected in November, Rose said, he still plans to "do what I said I was going to do," such as improving economic increase development, jobs, improve transparency and repeal taxes approved by the fiscal court last year. He said, however, that he has heard "rumors" that the fiscal court may address that issue prior to the new judge-executive taking office. Revenue from the insurance premium tax and the transient room tax are part of the draft budget presented at a recent fiscal court meeting. That budget, which must be finally approved by July 1, will carry the fiscal court into the 2018-2019 fiscal year.

Mayor Sharon Woods said the release of these funds is "wonderful" for Allen.

"It's wonderful. We can get some things done now," she said.
