Williams outlines goals, plans

Newly-elected Floyd County Judge-Executive Robbie Williams said he has big plans for Floyd County.

In an interview Thursday, he said his top priorities include recruiting jobs, working to develop potential industrial sites he has identified, prioritizing needs to improve county roads, improving county infrastructure, evaluating the county budget, putting more of an emphasis on combating drug abuse and other measures.

"I want to thank everyone that

Voter turnout improves in Floyd

Floyd County's voter turnout improved slightly since the primary election in May and was about the same as the turnout during the last midterm election in 2014.

"I thought we had a good turnout overall," County Clerk Chris Waugh said. "We had about 44 percent turnout, and we had about 13,367 voters, so, you could almost say it was 3,000 more votes than what we had in May."

Floyd County actually lost about 141 registered voters between the primary and general elections, but voter turnout increased by nearly seven percent, from 37.33 percent (or 11,341 voters) in May to 44.4 percent, or (13,367 voters) on Tuesday.

Waugh suspects that the higher turnout had some effect on the results of the general elec-

"The more people turn out, the more things can change. It can change races," he said. "When small groups of people turn out, you never know what could happen in a race."

The turnout for Tuesday's general election in Floyd County is about the same as the turnout reported in this county during the last midterm election in 2014. That year, 44.3 percent of Floyd County voters exercised their right to vote.

Statewide, 47.38 percent of voters cast ballots on Election Day, accounting for more than 1.6 million of 3.4 million registered voters.

Between the primary and general elections, Kentucky voter registrations increased by 35,000 and turnout nearly doubled statewide, from 23.9 percent during the primary election in May to about 47.4 percent on Tuesday.

Other local mayors had no opposition this year, but some other city government officials did.

Allen City Mayor Sharon Woods, who received 38 votes on Tuesday, Wayland Mayor Jerry Fultz, who earned 64 votes, and Wheelwright Mayor Don "Booty" Hall, who received 198 votes, had no opposition.

Incumbents for city government races in Martin and Wayland had no opposition on Election Day, but there was opposition on the city commissions of Wheelwright and Allen.

supported me, from the bottom of my heart," Williams said. "It was, I developed relationships, met people all over the county, great people. I want them to know that I have made promises, big promises, throughout this election, and I intend to keep them all. I'm going to work day and night to do what I promised the voters. I'm going to get jobs in here. We're going to feel good about living in Floyd County again. I want people to feel like they're part of something here."

Shortly after announcing his candidacy for the seat, Williams had already reviewed the county budget. He said he's identified two properties that could be converted into industrial sites and areas of the budget that could be cut.

"There's some things we can cut in the budget, but I prefer to, let's just hold our ground, at this point, and let's try to increase our tax base," he said. "And we do that by making the county more attractive for folks to live here, for people to want to build homes here and stay here and work, create jobs. I want to look for funding opportunities. I don't want to continue cutting basic services."

Williams, a political newcomer, will be the first Independent elected to the Floyd County judge-executive seat.

He was, however, registered as a Democrat about six months prior to signing up to seek the judge-executive seat.

"As far as being an Independent, I think in a true essence, yes, I've always been an Independent," he said. "I don't votes for Williams, 4,421 votes for Rose and 3,273 votes for Republican John DeRossett.

Rose won by a narrow margin of more than 30 votes when he campaigned against sitting Judge-Executive Ben Hale in the primary election in May, following a contentious campaign in which Rose rallied against "taxes, taxes, taxes," and he vowed to repeal the insurance premium tax the fiscal court approved if he were elected — a move the current fiscal court took shortly after Rose won the Democratic nomination during the primary election.

During a political forum held recently by Appalachian Newspapers, Williams said he had no intention of bringing back the insurance premium tax, adding an occupational tax or increasing taxes. He would not, however, take the option of increases taxes off the table when he talked about ways the county could increase revenue.

Addressing a question about the insurance premium tax, he said, "So, some of the things that we have to look at is budget cuts, initially. We have to get down there. We have to open the books up. Are we going to put the tax back on? We're not. I do not plan on putting the tax back on. Taxes, increasing taxes, is the easy way out. That's the easy way out. We have to find out how to generate more revenue, and that comes back to the economy. So what we're going to have to do for a while is we're going to have to

slow things down, open the books up, make sure we're getting the best bang for our buck, and, at that point, we can look at doing some things differently. But right now, we just have to stop the hemorrhaging."

Addressing a question about county debt, Williams said, "As far as putting an occupational tax on businesses in Floyd County, I don't agree with that at all. It's, the businesses that we have, it's just going to hurt the businesses. It's going to hurt the business growth. Now, for me to stand up here and say, folks, we're never going to increase taxes. That's not true. I wish I could say that and comfort you and make you all feel good, but I can't stand up here and say that taxes are never going to be increased. Anyone that does would

He pledged that if taxes have to be implemented or increased, the public would be involved in the process and he emphasized the importance of strengthening the economy in the county.

During the forum, Williams agreed that the county needs a strategic plan, saying his top three goals in that plan would be improving the economy and infrastructure, as well as taking care of the elderly residents and veterans.

He voiced support for renovating the Martin Community Center, which the fiscal court has been trying to sell for more than a year, saying he has a group that is ready to help with that

project.

Williams, a graduate of the former Wheelwright High School and Morehead State University, served nine years in the U.S. Marines and National Guard. After graduating college, he worked for a company that performed audits on fiscal courts throughout the state.

He went on to open several companies, including an accounting firm that he still owns. He said that work, however, won't interfere with his work at judge-executive.

"If elected, I have folks that can take care of the day-to-day operations of that business," he said. "I'm going to be a full time judge-executive."

In January, the majority of the Floyd County Fiscal Court will be new, as two new magistrates will be taking their seats alongside Williams.

Magistrate Mike Tackett won his re-election bid for District 3, beating a write-in candidate by more than 1,700 votes on Tuesday, but two other magistrates are finishing up their final months in office.

Democrat Mark D. Crider easily beat his opponent, Republican Floyd Skeans of Allen, with a vote of 3,380 to 1,004 for the District 1 magistrate, which is currently held by John Goble.

Goble and Magistrate Randy Davis is District 2 did not survive the primary election. George Ousley gained a majority of votes against Davis in May, securing his place on the fiscal court, come January.

through various projects that have begun under his administration. In January, he will start working with two new city council members.

On Election Day, voters re-elected Prestonsburg Council members Don Willis (758 votes), BD Nunnery (751 votes), C. Shaq Branham (746 votes), Harry Adams (685 votes), David Gearheart (679 votes) and Brittainy Branham (627 votes), but they ousted incumbents Mike Lafferty of Trans-Star Ambulance, who received 538 votes, and Roy Roberts, a sheriff deputy who received 499 votes.

New commission members were Rick Hughes, a Prestonsburg business owner and Prestonsburg Tourism member who received 754 votes, and Josh Turner, one of the volunteers who spearheaded the Sugarcamp Mountain Trials project. Three other candidates sought seats In Wheelwright, Commissioner Vernon Smallwood was ousted by voters. He received 148 votes — five votes less than the next highest voter-getter, Commissioner Andy Wayne Akers.

Akers will return to the commission with commissioners Bobby Akers, Sam Little and newly-elected member Dana McCown, a former city commissioner. The highest number of votes, 179, in this race went to Little.

Voters decided to keep its current commissioners, Clyde Woods, Elmer "Fudd" Parsons, Joshua Kinzer and Dr. Eilene Kinzer, in Allen. Parsons received 39 votes, Woods received 31 votes, Joshua Kinzer received 33 votes and Eilene Kinzer received 25 votes. Candidate Harrison Gibson did not meet his bid for a seat on the commission, pulling in only 15 votes that day.

vote party lines. I vote the individual. I've always felt like parties don't make decision. Parties don't prepare budgets. Parties don't hire and fire people. Those decisions are made by individuals."

Still, as an Independent, Williams had much to overcome in Floyd County, where a large portion of voters prefer making straight party-line votes. On Election Day, 2,575 people voted that way in the county, and there are no straight party-line vote options available for Independent candidates.

He said it feels "overwhelming," knowing that his election ends a decades-old Democratic stronghold on the judge-executive's seat.

He said, "There are so many people I have to thank in Floyd County. You just would not believe the support I got, and had to get, to overcome the...Democratic-leaning politics of Floyd County."

Talking about how 2,500 party-line votes "right out of the gate were off the board" for him on Election day, Williams said, "This is a big win. I feel like we've accomplished something here."

He beat Democrat James "Jimmy" Rose by 953 votes on Tuesday. The final tally was 5,374 laney Watts, DO

Halbert returns to jailer's seat

Floyd County Jailer Stuart "Bear" Halbert had nothing to worry about on Election Day, as he carried the largest vote majority of any other contested race in the county.

Halbert, a Democrat who is finishing up his first term in office, beat term," Halbert said.

Republican Emmit Johnson of Prestonsburg by a whopping 5,568 votes. He gained 73 percent of all votes cast.

The final tally was 8,829 cast in favor of Halbert and 3,261 votes for Johnson.

Halbert also defeated two other opponents during the primary election in May, carrying 4,700 more votes than the next highest voter-getter in that race. Not long after that election ended, Halbert's opponent for the general election was

Jarrell had a 419-vote majority over Hamilton. The vote was 2,137 to 1.718.

Constables of other districts had no opposition during the general election.

District 1 Board Member Linda C. Gearheart and District 2 Board Member Dr. Chandra Varia easily beat their opponents in the race.

Gearheart of Prestonsburg beat challenger Alan J. Gullett of Prestonsburg by about 500 votes. On Tuesday, 1,421 votes were cast in her favor, while Gullett received 922 votes.

Dr. Varia's victory margin was a bit larger. She beat opponent Shera Shelton Wagoner of Prestonsburg by about 860 votes, with a final tally of 1,651 to 794 on Election Day.

Together. We Rise. **GROWTH CONTINUES AT PMC WITH STATE'S APPROVAL FOR ADDITIONAL BEDS**

vices has granted Pikeville Medical Center (PMC) a Certificate of Need (CON) for additional acute beds, which will expand PMC to a 340-bed facility.

For patients, the addition of beds means they can stay close to home and receive quality care in their own community. They are not forced to travel miles away for care, saving them time and money.

Patients can continue receiving care from their own physician in the hospital with whom they are already familiar and the patient's family and friends can be close by for support.

PMC's additional beds were approved by the Cabinet for Health and Family Services following a six-day public hearing in Frankfort. The final order approving PMC's CON application was issued by Leslie C. Bates, administrative law judge. Judge Bates' opinion contained his findings, as tional beds at PMC," said CEO Donovan Blackwell as the ruling.

A CON is a legal document required in many states, including Kentucky, before proposed acquisitions, expansion or creations of facilities are permitted. Its purpose is aimed at keeping health care costs low while allowing new services and construction.

The CON approval came despite strong opposition from a number of area hospitals, including Tug Valley Appalachian Regional Hospital (ARH), Whitesburg ARH and Highlands Regional Medical Center.

The 49-page decision states that PMC's growth has increased in recent years. PMC is the only Level II Trauma Center in the state, it has the

The report notes that the number of patients being transferred to PMC from other facilities has also increased significantly since receiving Level II Trauma status. The findings show that PMC receives a high number of transfers from many hospitals throughout its service region, including the hospitals that opposed PMC's request for more beds.

In addition to trauma patients, hospitals continuously transfer patients to PMC to receive services they do not offer. The ruling notes, that opposing hospitals Highlands, Whitesburg ARH and Tug Valley ARH all transferred patients to The judge noted in his opinion that PMC appears PMC for a higher level of care.

"Our growth clearly shows the need for addiburn. "We operate at close to capacity many days. This ruling will allow us to move forward and ultimately allows us to keep more patients at PMC. We do not want to turn patients away, forcing them to travel hours away, to the nearest hospital with acute care that rivals our own."

The quality of services PMC provides, as well as its numerous accreditations and awards, were also considered in the Cabinet for Health and Family Services' decision to grant the CON. The judge found that PMC is continually recognized as a health care leader in its region.

"As determined by Judge Bates, smaller hospitals in the region depend on PMC to be a receiving facility for patients who require more specialized services," Blackburn explained.





to stand alone with regard to the level of service it provides. Because Eastern Kentucky is relatively isolated geographically, it is important for people to have access to both community hospital services and the more specialized services provided at PMC. CEO of Highlands, Harold C. Warman, Jr., testified he thinks "everybody recognizes that Pikeville is a valuable asset in the region. They offer certain services that some of the smaller community hospitals do not offer."

"PMC serves as a referral center for the entire region offering a broader scope of services at a higher level," said Blackburn. "Our hospital is fully staffed with talented, skilled specialists who are available 24/7. Other hospitals in the area do not offer the specialty services or the advanced equipment we provide."

Over the past 93 years, PMC has grown from a rural 50-bed hospital to a 340-bed regional referral center encompassing more than one million square feet on its main campus.

"This increase in bed capacity will allow us to provide highly specialized care to more people, keeping them close to home," Blackburn said. "We are pleased to continue to be a leader in health care for Eastern Kentucky. I am very proud of our ability to serve the needs of our community."

PMC demonstrated that it is committed to making high-quality specialty services available to oatients needs, so they can re their health care locally. Judge Bates concluded that PMC strives to provide optimal facilities, state of the art equipment, qualified and satisfied staff, and specialized physicians to deliver care.

They discussed options and opportunities for PMC and UPIKE to work together to further serve the community.

NEW SKIN CANCER TREATMENT AT PMC: NO INCISION, MINIMAL SCARRING

Pikeville Medical Center (PMC) has adopted the Xoft[®] Axxent[®] Electronic Brachytherapy (eBx®) System®, an advanced technology able to deliver a targeted dose of radiation directly to the surface of nonmelanoma skin cancer (NMSC) lesions. The Xoft System is FDA approved for the treatment of cancer such as NMSC, including basal cell carcinoma (BCC) and squamous cell carcinoma (SCC).

"This technology offers many potential benefits to NMSC patients, including excellent clinical results and fewer treatments, compared to traditional radiotherapy," said PMC Radiation Oncologist, Ruth Lavigne, MD. "It can be administered on an outpatient basis, and patients can resume normal, daily activities immediately following treatment."

The Xoft System uses a proprietary, miniaturized x-ray source to deliver a precise dose of targeted radiation directly to the surface lesion while reducing the risk that radiation will affect surrounding healthy tissue.

"This technology is great for the patient. There is very minimal scarring because there is no incision," said Radiation Oncology Manager, Terry Adams. "Also, the therapist can remain in the room with the patient, making them more comfortable."

At PMC, the Xoft System represents a potential alternative to traditional NMSC treatments, such as Mohs surgery, surgical excision, curettage or cryosurgery.

Appropriate candidates include NMSC patients with lesions in anatomically challenging locations (such as the ear, nose, scalp, neck, shin, and elbow), patients who may have trouble with wound healing, patients who

are on anticoagulants, or those with medical comorbidities that may preclude them from surgery.

"Mohs surgery continues to be the standard treatment for NMSC, but it can result in disfigurement or scarring for some patients, depending on the size and location of the tumor," added Lavigne. "As the incidence of skin cancer continues to rise in the U.S., our goal at Pikeville Medical Center is to bring our patients the widest range of clinically proven treatment options that support positive outcomes and the highest levels of safety and convenience."

Waiting in line to vote, we had lots of time to think Kentucky's post-election to-do list

With Election Day 2018 still fresh on our minds, we offer are a few suggestions to make voting more convenient and democracy stronger:

 Kentucky should offer early voting or at least no-excuse absentee voting.

Waiting to vote in Lexington on Tuesday, at least one person was observed ordering a pizza, having it delivered and eating it before reaching the front of the line. This incongruity between 21st century expectations and 19th century tradition makes for a good anecdote, but bad democracy.

Kudos to the many voters, especially in Lexington and Louisville, who stood in line for hours to exercise their right. The long waits stemmed mainly from a ballot lengthened by all the county offices and judgeships that were up for grabs. Of course, the ballot will be similarly long in four years and every four years after that.

wait in line for hours to vote, however. Kentucky law does require employers to grant employees four hours away from work to vote. But not everyone can afford to lose four hours of pay or to inconvenience their em-Owner-propriployers. etors of small - or even large businesses — cannot necessarily afford to leave them for hours on a Tuesday either. There are all kinds of reasons someone might have time to vote on a weekend but not on a Tuesday.

Kentucky is part of a shrinking minority of states (just 13) that offer no form of early voting. To vote absentee, Kentuckians must attest that they're going to be out of the county on Election Day.

In 2016, the state House, still under Democratic control, approved 12 days of early voting, including two Saturdays, after hearing about its advantages from Tennes-

Not everyone can see's Republican secretary of state. Tennessee (Tennessee!) has had early voting since 1994. Unfortunately, the bill died in Kentucky's Republican Senate and hasn't been heard of since.

> The 2019 General Assembly should allow Kentuckians the same convenience afforded voters in 37 other states and the District of Columbia.

 Require candidates to electronically file campaign finance reports.

Voters have few better ways to gauge candidates than by considering who's giving them money. Voters are supposed to be able to do that before an election by scrolling through the Kentucky Registry of Election Finance's web site. Despite disclosure laws, voters are being denied that information because so many candidates still file their campaign finance reports on paper.

This election's large number of candidates buried the Registry's 12-person staff under all that paper as more than 1,500 reports had to be hand-entered — making "a disaster election cycle for transparency," as Senate Majority Leader Damon Thayer recently told lawmakers.

A hardware upgrade will soon enable candidates to file electronically, even via smart phone, at no cost. The legislature should make sure by 2020 that's the norm.

 Restore felon voting rights.

We've oft bemoaned Kentucky's draconian denial of voting rights to felons who have paid their debt to society, a practice that brands our state with a shameful distinction: the nation's highest rate of black disenfranchisement. One in four black Kentuckians have lost the right to vote; the rate is even higher for black males: an estimated one in three. Still, it was painful to see Kentucky's

shame plastered across ing machines with new "The New York Times" in a pre-election article.

Gov. Matt Bevin, an ardent advocate of second chances for felons and criminal justice reform, has done remarkably little to actually achieve those goals. Contrast that with Florida where on Tuesday voters approved a constitutional amendment that will automatically restore most felons' voting rights, adding a possible 1.4 million voters to the rolls. The legislature should give Kentucky voters the same opportunity by putting such an amendment on the ballot in 2020.

 Upgrade voting machines.

Voting equipment that was state of the art when it was new is showing its age in Lexington and elsewhere. Local governments could use help from Congress, via funding for the 16-yearold Help America Vote Act, to replace aging votmodels that produce a paper audit trail.

GOP maintains control in Ky. House

FRANKFORT — Democrats were unable to flip the Kentucky House or even reduce the GOP supermajority, but there will be a lot of new faces - many of them women - in the chamber when lawmakers convene in January.

Two Jefferson County Republicans, Phil Moffett and Ken Fleming, were defeated by Democratic women, Lisa Bojanowski and Maria Sorolis, respectively.

A pair of House seats that have flip-flopped between two candidates, have flipped once again. 91st District, incumbent Republican Gary "Toby" Herald, who narrowly defeated Democrat Cluster Howard in 2016, found himself on the losing end to Howard this time.

The same holds true in Daviess County's 13th District, where Democrat Jim Glenn, who lost to Republican DJ Johnson two years ago, recaptured his seat, by a one vote margin, 6,319 to 6,318. There will likely be a recanvass request by Johnson for that seat as well as one by incumbent Democrat Jim Greer in the 27th District, consisting of parts of Bullitt, Meade and Hardin

In Eastern Kentucky's counties. He lost by six votes to Republican Nancy Tate.

> Democrats also captured two other Eastern Kentucky seats held by Republicans who were elected during the socalled "Trump Tsunami" of 2016, but those gains were mostly offset by GOP victories in most of the open seats that had been held by Democrats.

Republican Two House members who were accused of inappropriate behavior toward women were re-elected.

Michael Meredith of Brownsville signed a secret sexual harassment settlement last year along with three other GOP

lawmakers. In April, the Leader Rocky Adkins, Legislative Ethics Commission dismissed ethics charges against him. He handily beat Democrat William "Bill" Fishback.

Jim Stewart of Flat Lick was accused of making unwanted verbal advances to a female courier in 2015, according to a memo from the former chief of staff of the House Republican Caucus. Stewart has denied the allegations, easily won over Democrat Debra Ferguson Payne.

When all is said and done, the Republicans, who had a 63-37 supermajority, will remain with more than 60 members. House Democrat

D-Sandy Hook, expressed his disappointment, saying, "While I wish we had a better overall outcome, I am proud of the hardfought victories we had in many districts. I saw first-hand that our candidates and their supporters put everything they had into their campaigns, but we faced an uphill battle because of a nationalized climate and the unfortunate rise of dark money and negative attacks." for

Kentuckians Strong Leadership, a top Republican Super PAC in Kentucky, invested more than \$600,000 in this year's state legislative elections. KSL bought television, radio, digital, and direct mail advertising in several winning campaigns.

"We were proud to help the Republican Party win the State House in 2016, and proud to help the GOP hold it in 2018. Kentucky is better with Republicans in charge in Frankfort," said KSL chief strategist Scott Jennings.

The Republicans were expected to face more of a challenge by teachers angry about pension reforms. At least nine of 36 current or former teachers on the ballot won seats in the Legislature, falling far short of their goal to end GOP reign.

No annexation for Spradlin Branch, voters say

Voters who live in Spradlin Branch overwhelmingly opposed being annexed into the City of Prestonsburg on Election Day.

According to unofficial results released by

the Floyd County Clerk's office, 54 Spradlin Branch voters opposed the annexation, stalling the city's chances of moving forward with the proposal for at least five years. The annexation would have continued

if less than 55 percent of voters approved the

measure, but only nine days to file a petition to people voted "Yes" at the polls.

Prestonsburg The City Council approved an ordinance declaring the city's intent to annex more than 120 acres on Spradlin Branch in March, and resident voters or property owners had 60

ask that the annexation be placed on the ballot.

A certified a petition was filed on behalf of residents in May, with County Clerk Chris Waugh reporting that half of the property owners signed it in opposition to annexation.

The Prestonsburg City Council waived its right to object to some of the names on the petition, which would have potentially disqualified it in August, allowing the question to be placed on the ballot.

The city planned to annex Spradlin Branch,

PSC approves Kentucky Power assistance programs

Revamped program offers more heating season aid to low-income customers

SPECIAL TO THE FLOYD CHRONICLE AND TIMES

The Kentucky Public Service Commission authorized Kentucky Power to provide additional assistance to low-income residential customers who are having difficulty paying their home heating bills.

In an order issued recently, the PSC approved a joint proposal by Kentucky Power and Community Action Kentucky, Inc. to revamp the company's existing program. CAK administers assistance programs for Kentucky Power.

Kentucky Power and

CAK proposed to revise the existing Home Energy Assistance program (HEAP) to provide greater benefits in the winter, renaming it Home Energy Assistance in Reduced Temperatures (HEART).

The applicants also proposed a new program called Temporary Heating Assistance in winter (THAW), aimed at customers who need more limited assistance.

The changes will take effect prior to the upcoming winter heating season.

Key aspects of the HEART program include: Eligibility deter-

mined by participation in

the Low Income Home Energy Assistance Program, or LIHEAP, the federal program that provides energy assistance funds during the winter months.

 An increase to \$115, from the \$65 under the program to provide as-HEAP program, in the monthly benefit for participants using electricity as the primary means of heating.

The monthly benefit for eligible residential customers using a different primary heating source will increase to \$58, up from \$33 under the HEAP program.

• A shift of the fourmonth period during which payments are made to January through April, rather than December through March, to better align it with the time during which high electric bills arrive.

 Discontinuing а sistance for air conditioning bills during the summer months in order to increase benefits in the winter.

• Requiring participants to enroll in Kentucky Power's average monthly billing plan, which reduces monthto-month fluctuations in bills, enabling customers to better manage their energy payments.

The THAW program will provide up to \$175 per heating season to customers who are ineligible for LIHEAP or the HEART program, but who may require assistance with one or two monthly bills during the winter. It also will extend from January through April, or until available funds are expended.

Like the HEAP program, the HEART and THAW programs will be funded by a 30-cent monthly charge on each residential meter, with the revenue matched dollar-for-dollar by Kentucky Power's shareholders. For the 12 months

ended in August, the revenue and matching funds totaled about \$765,000, according to data provided by Kentucky Power.

Kentucky Power and CAK stated that 75 percent of the funds will go to the HEART program, with the remaining 25 percent to the THAW program.

The HEART program is expected to serve 1,535 customers with electric heat and 537 customers with non-electric heat in 2019, while the THAW program would assist 1,530 customers next year, Kentucky Power said.

was limited, appearing in only four games for the Jaguars. Conn hauled in six receptions for 125 yards and two TDs.

Boyd grabbed two scoring catches as Floyd Central managed to mix passes into its offensive attack.

Defensively, Brady Jones led Floyd Central with a team-high 82 tackles. Brenden Little added
