# Lawmakers end special session

Kentucky lawmakers go back home without dealing with pension crisis

Flustered by magnitude of Kentucky's public pension crisis, lawmakers abruptly concluded a special legislative session on Tuesday,

without making needed financial repairs.

Kentucky's retirement the systems have long been among the worst-funded in the nation, needing some \$43 billion to be restored to solvency.

Lawmakers had opting to return home passed a law earlier

this year to funnel more money into the retirement systems. But last week, the Kentucky Supreme Court struck down that law on procedural grounds.

Republican Gov. Matt Bevin summoned lawmakers back to Frankfort on Monday to make fixes that would appease justices. But after meeting with Republican legislative leaders, the governor See SESSION, Page 8A

# Grand jury alleges caretakers stole money from elderly residents

#### **By MARY MEADOWS** STAFF WRITER

A Floyd County grand jury indicted two people this month for allegedly stealing money from elderly residents in two separate incidents.

"We get a lot of complaints of this kind of thing, the financial exploitation of elderly people, but we don't get many cases where we can actually do something," Floyd County Commonwealth's Attorney Brent Turner said.

The grand jury indicted Cynthia Kidd, 53, of Harold, charging her with one count of theft by deception, for alleaedly stealing from an elderly man in her care, and an indictment was also issued against Gary Crum, 60, of Banner, for allegedly stealing money and other items from his mother.

The Class C penalty against Kidd carries a potential penalty of between five and 10 years imprisonment.

According to the indictment, Kidd "intentionally deceived" a 95-year-old man she was hired to care for by having him execute a Power of Attorney, a document that gave her the authority to act on his behalf in legal and financial matters.

The indictment al-

leges that Kidd used that Power of Attorney to allegedly withdraw more than \$30,000 from the man's saving account and that she used those funds "for her own benefit."

Turner said she used approximately \$20,000 of those funds to buy a Jeep, which was confiscated when Kidd was arrested on Tuesday.

The alleged theft took place between Oct. 23 and Oct. 25.

According to records filed in the Floyd County Deed Office, Kidd was assigned as Power of Attorney over the elderly man on Oct. 23. A document revoking that Power of Attorney was filed in the clerk's office on Dec. 3, the records show.

tim is a 95-year-old Floyd County resident who is "very independent" and Kidd was "recommended to the family" as someone who could come by several times a week to spend time with him and do light housework.

The elderly man's children who live in another state sought help after learning that their father's money was missing, Turner said.

"So, they were actually very happy, I think, with her initially, and then she just kind of disappeared there, after she got that money," Turner said. "She didn't come back and they couldn't find her, and then they get to looking at his finances and realized that she's used that Power of Turner said the vic- Attorney to take all of his money."

Turner encourages local residents who have hired Kidd to review the finances of their loved ones.

"My understanding is that she's someone that's done this kind of work with elderly people and sat with people a lot in the area, and there's a lot of people that have hired her for that and know her," Turner said.

When asked if he suspects that Kidd has committed this alleged crime elsewhere, Turner said, "I don't know, that's something that we would obviously tell people that if she's someone that you've hired, you should probably go and check with your loved one or whoever she was around and check your finances."

He said officials are glad that the Jeep was confiscated, which, if Kidd is convicted, could help the elderly man recoup some of the money. In the other case

alleging theft from an in a yard sale. elderly resident, Crum faces felony counts of second-degree burglary, theft by unlawful taking, second-degree criminal possession of a forged instrument and knowingly exploiting an adult over \$300. The grand jury also filed a misdemeanor charge against him, second-degree criminal possession of a forged instrument.

Floyd County Sheriff's Department Sgt. Oliver Little, who arrested Crum in October, previously told the Floyd County Chronicle and Times that Crum's mother contacted adult protective services because she feared for her safety. He reported that the woman "had to check herself in a nursing home to feel safe."

Little alleged that Crum broke into his mother's home and stole items, including a checkbook, and he placed some of the stolen items

He also used his mother's vehicle without permission, Little previously reported.

"She was having mobility problems and due to the fact that he just refused to help her any and told her the only way he would help her was if she signed Power of Attorney rights over to him. And then the fact that he had financially abused her, that falls under the adult abuse, elder abuse case. Just the financial abuse in general was the primary reason for that charge," Little said in October.

He alleges that Crum threatened to kill his mother if she did not give him Power of Attorney.

"My understanding is her son, Mr. Crum, had actually threatened to kill her if she didn't sign Power of Attorney rights over, and that's when she decided to check herself into the nursing home," Little said.

game in Ashland and for allegedly verbally abusing students.

District officials announced disciplinary action against Spurlock for "conduct unbecoming of a coach," but Spurlock denied the allegations.

Eight Floyd Central players quit the team after the incident, the parents said.

Parents Sandra Johnson and Angie Hurd told board members Monday, however, that they believe Spurlock's punishment was not harsh enough.

"I don't feel like a three-day suspension was enough," Johnson said. "I ask you all to reconsider this. Our children have been verbally abused. They have been mentally abused. They have been bullied."

She said she understands the district has policies in place, but insisted the board reconsider Spurlock's punishment.

"I know that these eight boys are a number to you all, but these eight boys are our babies ... and we feel like they've not getting justice," Johnson said. "We've come up the command chain and we've asked that we be heard."

She chided officials for the suspension, saying, "All you're doing is telling Mr. Spurlock he's untouchable."

She told them, "You have eight varsity players that have quit the team. One is one of the top players in your 15th Region in his senior year, that don't want to play for this man. If it was one or two, I'd say, yeah, maybe...Eight, come on, you all. I'm asking you all to please reconsider this."

No action was taken on the matter, but board officials are expected to respond to the request in writing.

She asked that every child be re-interviewed.

The board did not respond publicly to the allegations. Chair Sherry Robinson noted that the board's practice is to respond to comments in writing within five days. The response was not available prior to print deadline.

Later in the meeting, the board voted to go into executive session, citing an exception to the open meeting that permits closed session discussions that might lead to the appointment, discipline or dismissal of an employee.

Prior to going into closed session, Superintendent Danny Adkins cited a state law regarding the board's duties.

"Real quick, I would like to say something that completely slipped my mind," Adkins said. "It's something I'd like for everybody to know. Pursuant to KRS 160.170, every person elected to a board of education shall, before assuming the duties of this office, take an oath in addition to the constitutional oath, that he will not while serving

Hurd, the mother of another senior, asked the board to reopen the investigation into the "Ashland incident."

"I have a outside witness with no ties to Floyd Central who's willing to collaborate our story about what happened," she said.

She presented a letter from that person, whom she described as an assistant coach from another school.

"This is my letter discussing the issue that happened in Ashland and the assistant coach from another school who saw it and asked me, 'Is it always like this?' and I said, 'This is year two and it's just getting worse,'" Hurd said.

She complained that the investigation lasted only 20 hours.

"We had our meeting at 6 o'clock, by 2 o'clock the next day, we had a decision. Everyone knew except for the parents that had gathered in the decision," Hurd said. "Twenty hours to investigate a bullying allegation and a incident in Ashland that was completely unnecessary. He should have to pay for that. I don't think a three-day suspension covered what happened in Ashland, let alone what every child came forth and spoke about."

# Trio accused of stealing a bridge

In the past two decades, Floyd County Commonwealth's Attorney Brent Turner has seen cases where all sorts of thefts are alleged, and scrap metal is certainly on that list.

"With the scrap metal stuff, they'll steal about anything," Turner said. "They used to steal manhole covers and things in Hazard."

But the allegations in an indictment issued recently by the grand jury marks the first time Turn-

er has dealt with a case of a stolen bridge in Floyd County.

"The allegation was that they stole a bridge, that they took a bridge apart, like one of these small metal-type bridges that maybe leads to one residence or something or goes over the creek. And then they took it apart for scrap metal," Turner said.

He was talking about the indictment issued last week against a Floyd County resident and two Pike County residents who are accused of taking apart a metal bridge

and stealing it.

Kimberly Mimnaugh, 46, of McDowell, Jerome Norman, 37, of Raccoon, and Michael Pinion, 38, of Raccoon, were each indicted on one count of felony theft by unlawful taking in these cases. The alleged theft took place in March, according to the indictments, and the bridge was valued at more than \$10,000.

and Pinion are scheduled to appear in Floyd Circuit Court for an arraignment on the charges against them on Jan. 2.

fight started between two females before the that when he arrived, Christmas play began in the church, and it "spilled outside" with the husband/boyfriend of those women. Several assaults were reported in the case files, including injuries to a child, the child's mother and grandmother and he was punched when he tried to break up the fight.

Prestonsburg Police Officer Ross Shurtleff arrested Mark Anthony Gilliam, 21, and his girlfriend, Tabitha Ann Compton, 20, both of Hi Hat, after the incident allegedly occurred at the Trimble Chapel Church on Watergap Road on nesses and family mem-Dec. 16.

Shurtleff reports in the court filings that he was responding to a report from Kentucky State Police Trooper D. Coleman, who alleged an

"irate" man was "fighting with the congregation and possibly had assaulted a child."

Shurtleff reported members of the congregation were standing around the church's parking lot blocking the roadway to prevent Gilliam and Compton from leaving the premises.

Shurtleff wrote that Gilliam would not answer the preacher's claim that his questions and, at one point, he "lunged toward" him in a "menacing manner" and was "creating a disturbance amongst an already upset church congregation."

Shurtleff alleges that Gilliam and Compton came to the church to watch a Christmas play that featured his children.

"In speaking with witbers, I learned that (Gilliam and Compton) came to the church to watch a Christmas play that featured (Gilliam's) children whom he had in common with his wife, a victim,"

Shurtleff wrote. "As (Gilliam and Compton) arrived, the girlfriend and wife began having a verbal altercation which became physical and spilled outside."

He alleges in the document that Gilliam assaulted his wife and choked her. The victim's mother, who was holding the youngest of three children, was "knocked to the ground" by Compton, the documents say.

Compton was charged with fourth-degree assault and second-degree disorderly conduct, both misdemeanor charges. She pleaded not guilty during an arraignment on Monday and District Judge Eric Hall also ordered her to have no contact with the victim in the case and to have no violations of the law. She was released from custody that day on a \$2,000 surety bond.

Gilliam was charged with two counts of fourth-degree assault, one of which is listed as

"child abuse." He was also charged with secdisorderly ond-degree conduct, menacing and resisting arrest. Shurtleff arrested him on those charges and transported him to the Floyd County Detention Center.

The following day, in a separate case, Trimble Chapel Church Preacher David Bowling filed a complaint against Gilliam, alleging that Gilliam hit him in the face while he was trying to separate the fight. Gilliam was charged with fourth-degree assault in that case.

Gilliam pleaded not guilty in both cases during his arraignment on Monday. Hall ordered him to have no contact with the victim or the child in the case, assigning him a 500 ft. retraining order and requiring him to follow social services orders. He set Gilliam's bond at \$500 cash in both cases. Hall scheduled a court trial in both of those cases for March 14.

### Jail officials: Woman threw urine on deputies

#### A FLOYD CHRONICLE AND TIMES STAFF REPORT

A Floyd County woman was arrested for charges in four separate felony cases this month for allegedly breaking a window and trying to sneak drugs into the jail, and then allegedly assaulting deputies by spitting, kicking and throwing urine on them.

Floyd County Detention Center Lt. Parker DeRossett filed the four felony cases against Mikayla Wallen, 21, of Louisville, this month.

Wallen has pleaded not guilty to all of the charges and District scheduled preliminary hearings to be held in each case on Jan. 2.

DeRossett claims in documents filed in Floyd District Court that Wallen broke a window in a visitation room at the jail by repeatedly kicking it on Dec. 7.

She was charged with first-degree criminal mischief, a felony, in that case, with officials claiming she caused approximately \$2,400 in damages at the jail.

The court filings show that Wallen was taken to Highlands Regional Medical Center later that day, and over the next couple

Judge Jimmy Marcum of days, more felony casscheduled preliminary es were filed against her.

> On Dec. 7, Jail Deputy Bill Henegar reported that Wallen had hidden drugs inside her person while she was at the hospital, DeRossett alleges in one case.

He claimed that he examined a clear bag filled with a "large amount of clear crystal like substance believed to be methamphetamine" that was allegedly recovered in that investigation.

Wallen was charged with first-degree promoting contraband, possession of drug paraphernalia, first-degree possession of a controlled substance and tampering with physical evidence in this case.

On Dec. 8, Wallen was charged again, at the hospital, with one felony count of third-degree assault and menacing.

DeRossett alleges in that citation that deputies Henegar and Tammi Oskarek were watching Wallen at the hospital and she was trying to get out of her restraints.

When Henegar went to check those restraints, Wallen allegedly spit on him, "kicked him in the head" and threatened to kill him, DeRossett claims. On Dec. 9 — the day Wallen was served with arrest warrants in all of these cases — DeRosset claims that Wallen asked Oskarek to use the phone while she was in the hospital's intensive care unit.

DeRossett claims that Wallen "became mad and loud" when she learned she couldn't use the phone and she "picked up a bed pan with urine in it and threw it at Oskarek, "covering her from the neck to waist with urine."

Wallen was charged with third-degree assault and menacing in that case. Wallen appeared in Floyd District Court last week and entered not guilty pleas in all cases against her.

Marcum set separate bonds for each of the cases totaling around \$9,000.

These are not the first felony cases Wallen has faced in Floyd County this year.

In November, she was arrested for first-degree drug trafficking for allegedly bringing more than a pound of methamphetamine to Floyd County.

That case was referred to the grand jury for consideration.

### Bevin says calling special session was necessary

Gov. Matt Bevin said on a talk radio show in Huntington that a special session that he quickly called on Monday afternoon was imperative because of current lawmakers' familiarity with the pension reform issues and finances in Kentucky.

He said that the new House bills proposed add nothing new from Senate Bill 151, so there should be less discussion and questions among legislatures.

"It's nothing that hasn't been debated ad nauseum in the 2018 legislative session," Bevin said on the Tom Roten Morning Show on WVHU 800 AM Tuesday mornHouse Bill 1 and House Bill 2 were introduced late Monday night by Rep. Jerry Miller, a

Louisville Republican. "Senate Bill 151, which they already passed, is broken into two pieces with many parts removed, some of the most contentious parts, the parts that judges ruled against whether they should have or not," Bevin said. "The logic is we need to start with the basics."

Breaking the previous pension overhaul into two pieces made sense, he said.

"If we don't have the ability to pass comprehensive pension reform bill in one fell swoop, we will eat this apple one bite at a time."

Bevin said House Bill 1 only affects new hires and House Bill 2 has only one issue that applies to current employees starting in 2024 concerning what Bevin called a "multiplier by which they can spike their pension." Ending that is an idea that came from school superintendents and one that has been discussed in the legislature, he said.

If they waited to address the pension reform in the 2019 General Assembly session, which begins Jan. 8, there would be new faces who wouldn't know as much about the pension reform plan that the Kentucky Supreme Court unanimously struck down four days ago for procedural problems, he said.

"There's nothing new that hasn't been heard of. talked about or discussed by these particular members." Bevin said. "You have to realize some of these members too won't be coming back. Some are retiring and some lost their seats (in election). We start next year it's a whole new group of people, not all who have been through this discussion month after month after month."

The idea of calling the special session on Monday was that it could be completed before Christmas, he said.

"They could be done on Friday, that was the whole purpose of starting on Monday to get the first reading yesterday (Monday), second today (Tuesday), and third in the House Wednesday. The Senate gets its first Wednesday, second (reading) Thursday and third (reading) and vote on Friday. It could be done in that short order."

House Minority Leader Rocky Adkins, D-Sandy Hook, called the special session "appalling" and Attorney General Andy Beshear said bringing lawmakers back during this time of year was cruel.

Bevin said Adkins, a gubernatorial candidate, hasn't offered a solution to the problem.

"Here's what's crazy. This is a guy who literally thinks he should be governor, has filed to become governor and is running to become governor," Bevin said. "He thinks it's appalling that we are trying to save a failing pension system, but he doesn't have a solution.

"We're dealing with people so far removed from financial reality. They do not understand what's at stake."

Bevin said the solvency of Kentucky, the credit ratings of Kentucky, debt issuances of Kentucky, the bankers, business people and taxpayers are under financial assault if the pension system fails.

"We have some of our leading Democrats Whistlin' Dixie here past the graveyard and pretending that there is no problem and it's a shame."

# Officer's killer to serve life in prison, no parole eligibility

PIKEVILLE — A Pikeville man charged with capital murder for the March death of Pikeville Police Officer Scotty Hamilton entered into a plea agreement to two of his five charges in the case and was sentenced to serve life in prison without the possibility of parole during hearings held in Pike Circuit Court Wednesday.

John R. Hall, 56, of Hurricane Road, Pikeville, entered into a plea agreement in which he pleaded guilty to murder for Hamilton's and also to a charge of being a convicted felon in possession of a handoun. Pike Commonwealth's Attorney Rick Barltey recommended that three other charges - receiving stolen property, a convicted felon in possession of a firearm and a persistent felony offender charge — be dismissed. Bartley said two guns had been located during the investigation, a rifle and a handgun, and the handgun was identified as the murder weapon. During the hearings, Bartley was joined at the prosecution bench by Kentucky State Police Sgt. Randy Combs and Pikeville Police Chief Chris Edmonds.

In the agreement, Hall also stipulated that he had committed the murder while Hamilton was working and on duty as a police officer, which allowed for the pursuit of enhanced punishments through the state. were ordered to run concurrent with each other.

According to Bart-A ley, Kentucky does not allow for any sentences for to extend more than life, ke- therefore he could not tty make recommendations of a life sentence plus 10 wo years, as the maximum the allowed was life.

A pre-sentencing report, which usually creates a delay between when plea agreements are entered and the sentencing phase, was prepared in advance of Wednesday's hearing as both prosecutors and defense said they were prepared to "get this behind us today."

Hamilton's mother, father, brother and widow each signed agreements to the plea agreements. Hamilton's mother, Patricia, spoke during the hearing.

"Because of you, my heart is broken, as is our family's, friends', his brothers in blue and the community he loved so much. Because of you, our lives are forever changed, but yours will change to," Patricia Hamilton said to Hall. "Scotty's senior quote for graduation was to 'Live life to the fullest, take one day at a time," and that he did."

Bartley said, Hamilton's brother, Jeff, would decline to speak out of respect for the court as he was "too upset to make a statement, ... without, frankly, being inappropriate for the court room."

young daughter, Brynlee, searching for their "new normal."

"On March 13, ... our lives were turned for the worst when I lost the love of my life, my best friend and the father of my little girl. In these past couple of months, I have experienced a roller coaster of emotions with this case. I want justice served for my husband ... Scotty's main priority in life was the care of his daughter and to know he won't be around to see his daughter go to her first day of school, attend her first dance, to see her graduate or to be there to walk down the aisle is heartbreaking," Ray read. "We now have to find our new normal in life because that is what Scotty would have wanted us to do."

After the statements, Pike Circuit Judge Eddy Coleman accepted the plea agreement and the sentence recommendations and ordered Hall sentenced according to the agreement. Coleman ordered that Hall be returned to the custody of the Clark County Detention Center where he is currently being held.



With the plea agreement, Bartley recommended a sentence of life without the possibility for parole for murder and 10 years for the handgun violation. ### Deputy: Man pulled a knife on firefighters
