

## Big Sandy District In No. 1 EDA Spot

### Area First Designated In Nation

#### EDA Official Says All Area Projects Now in Washington

The five-county area served by the Big Sandy Development District received encouraging news Tuesday, and so did the Prestonsburg area.

Thomas Francis, Washington, D. C., director of the Office of Development Districts, Economic Development Administration (EDA), told representatives of the five counties at a May Lodge luncheon meeting that the Big Sandy district is the first of its kind in the nation to be officially designated as such by EDA and that this prime status entitles the district to a 10 percent bonus of funds for future programs.

The good news to the local area came from Bill Davis, director of the mid-eastern EDA office at Huntington, W. Va., who announced that "all projects you people have given us to send to Washington have been sent." That meant that the \$5 million regional hospital proposed for construction on new US 23, between Prestonsburg and Auxier, has cleared the Huntington EDA office and is in Washington for final action.

The Department of Health, Education and Welfare has already made available a grant of \$1.3 million to help build the hospital, which is planned initially for 150 beds and can be expanded to accommodate 350.

## CAMP SITES 'WINTERIZED'

### But May Be Opened For Some Unaware That Season Over

Camping facilities at all Kentucky State Parks have been "winterized" and are officially closed for the season, Commissioner of Parks Robert E. Gable has announced.

The camping season closed November 15 and will reopen April 1, 1969.

"Although the camping facilities are closed, "the Commissioner said, "it is our policy to treat with consideration requests from campers who have traveled great distances without realizing that the camping deadline has passed.

"Campers who do not require the use of such facilities as water and rest rooms, which are among those being protected from winter weather, will find state park managers making every effort to provide parking space for overnight campground guests."

Due to the seasonal nature of camping activities and the fact facilities are designed for summer use, the "winterizing" process is thorough and cannot be temporarily set aside even though Kentucky has some good camping weather in winter. (See Story No. 10, Page 6)

## Christmas Vacation For College, Schools To Start Tomorrow

Prestonsburg Community College and the schools of the county will begin their Christmas vacation with the end of Friday's work.

Schools of the county system will resume work on January 2, but the college will not return to classwork till January 16.

Because of an outbreak of influenza, Pikeville College took an early Christmas recess, beginning its Christmas vacation last Monday. Work will be resumed January 6.

Ten faculty members there were reported ill of flu, and approximately half the student body was absent last Monday for the same reason.

## 183,481 in Kentucky Received USDA Food In October, Report

Atlanta, Ga. — U. S. Department of Agriculture food programs aided 183,481 needy persons during October in 77 Kentucky counties.

USDA's Consumer and Marketing Service said 64,825 persons in 65 counties took part in its commodity distribution program and that 118,656 persons in 52 counties took part in its food stamp program.

October's participation was up 2,974 from the number that took part in the programs during September. This increase is attributed mainly to a seasonal decline in employment. (See Story No. 11, Page 6)

## Sunday Closing Here Is Delayed

Enforcement of the state Sunday closing law did not go into effect here last Sunday, as scheduled, and doubt was expressed this week that anybody will be penalized for violation until after the holidays, if then.

At least two of the businesses which had sought Sunday closing announced this week they will be open next Sunday.

A spokesman for the group asking enforcement said he and others were interested in knowing why the chief of police did not swear out warrants and make arrests after places of business remained open last Sunday. Chief of Police Bill Potter said he has been on vacation two weeks and did not return to duty till Monday.

The City Council at its Dec. 5 session heard the request of several business men for Sunday closing and voted strict enforcement. This was followed by warnings from police that those who kept their stores open the following Sunday, Dec. 12, would be subject to arrest and prosecution. One store manager later indicated he and others, in defense of their businesses, would in turn take legal action seeking compensation for damages resulting from their closing.

Mayor George P. Archer said last week that if enforcement is undertaken here it will be impartial, with no favorites. He also said any attempt to close Prestonsburg businesses on Sunday would necessarily have to be accompanied by similar action over the county.

Further consideration of the controversial topic is expected to be given at the council meeting tonight (Thursday).

## PARTY PICKS P'BURG ATTY.

### Burchett Elected As District Posts Won by 'Regulars'

The "regular" Democratic party organization in this county, as in practically all other counties of the state, won handsily in last Saturday's poll of precinct committeemen.

W. W. Burchett was elected county chairman here Saturday afternoon, and Alex H. Spradlin was re-elected secretary. Mr. Spradlin next month will begin his 45th year of service to the party in that post.

The organization fight, if any, really ended with the voting for precinct committee chairman, Dec. 7. Party regulars won in that poll, and last Saturday morning the precinct chairman—three for each precinct, since a "youth" chairman was added under party rules this year—met to elect legislative district chairmen. ## 3 WOUNDED IN MAGOFFIN

### Carver Postmistress Shot; Wife Held In Adkins Shooting

Three persons, a woman and two men, wounded in Magoffin county shootings, were brought to the Prestonsburg General hospital on successive nights last week. All are expected to recover.

Mrs. Myrtle Conn, 60, postmistress at Carver, and her husband, Vester Conn, 59, were taken to the hospital last Wednesday night after they had been shot at their home, allegedly by J. C. Craft, 40, Mrs. Conn's son by a former marriage.

One shot from a .25-calibre automatic pistol struck Conn in his abdomen and another fractured his arm. Mrs. Conn was shot in her right hand.

On the following night Charles Lee Adkins, 40, Bloomington farmer, was brought to the hospital here with a .22-calibre bullet wound which entered his chest below his heart and ranged into his abdomen. His condition was serious but he is recovering, it was said at the hospital Wednesday.

Adkins' wife, Sue Dell Adkins, 40, surrendered to Magoffin county officers last Friday and executed \$5,000 bond to answer to the Magoffin grand jury when it convenes in February.

## FIREWORKS SUIT TOPIC

### Tennessee Firm Asks Injunction Requiring Truck Cargo Return

A Tennessee firm whose cargo of fireworks was confiscated Dec. 7 and its driver fined filed suit in circuit court here Wednesday against Magistrate Bill Wells, of West Prestonsburg, asking a temporary injunction directing the official to surrender to plaintiff its property and refund its driver's fine.

The plaintiff, Edens Enterprises, Inc., says its driver, E. J. Bradford, was charged in a warrant with transporting fireworks for resale, in violation of KRS 438.110, the Kentucky statute governing the sale of fireworks in Kentucky, and that the driver, not advised of his rights, entered a plea of guilty.

The fireworks confiscated totalled about 250 cases, valued by the plaintiff at approximately \$3,500.

Plaintiff contends it was not in violation of Kentucky law, since plaintiff is a wholesaler of fireworks and is licensed as such under Tennessee law.

The arrest of the company's driver was made by state police.

## Dr. Kirwan Lauds 2-Year Colleges

### Immunization Clinic Scheduled at Dwale

The Floyd County Health Department and the Floyd County Comprehensive Health Services Program will jointly sponsor an immunization clinic at Dwale, Monday, December 23. The clinic will be held in the rear of the Dwale postoffice building from 10 a.m. to 12 noon, and from 1 to 2 p.m.

A nurse from the Health Department will give shots to babies or children who have not started or completed their immunization, and to adults for tetanus or smallpox immunization. Children under 12 years of age may also receive their free measles shots.

## BREAKS PARK BIDS OPENED

### Improvements Costing \$1 1/4 Million Planned During Coming Year

Improvements costing approximately \$1 1/4 million are scheduled next year at Breaks Interstate Park, near Elkhorn City.

Bids were opened, early this month, on two contracts. The first, which includes a swimming pool, six motel units, cabins, picnic shelters, camp grounds, a small boat dock, and an addition to the restaurant and service building, may go to the Trammell Construction Company whose bid of \$908,600 was lowest of four submitted.

The second contract is for road and parking lot construction. The Adams Construction Co., Pikeville, was low bidder (See Story No. 9, Page 6)

## Floyd Library Aid Seen for 20 Years

The first check due under a contract with the Kentucky Department of Libraries which may over a 20-year period benefit Floyd county in excess of \$140,000 is expected to be received here shortly by the Floyd County Library Board.

The initial check will be \$7,276. The state library-aid plan announced by Governor Louie B. Nunn envisions payment of the same amount annually to the board for 20 years.

The new library funds are to aid construction of new libraries or additions to existing library structures.

In the case of Floyd county the contract recently executed by the library board here provides for increase of the library floor area from 6,700 square feet to 8,328. This will be done by construction of a one-story addition at the rear of the present building.

Cost of the addition and equipment is expected to be around \$50,000. George Lee Shannon, Prestonsburg architect, is preparing plans for the addition, and bids are due to be opened February 27.

State funds accruing to the Floyd board through the contract also may be used to amortize existing construction indebtedness.

The new portion of the building is planned to include a small auditorium for community meetings and house facilities for audio-visual equipment and color television for educational TV.

As a consequence of the new library-aid plan, a minimum of 20 new libraries will soon be under construction in the state. Others which have buildings, as has the Floyd County Library, will benefit from enlargement of their buildings.

## Ceremonies Mark Start Of Buildings

### Acting UK President Sees Added Services Rendered by College

"Prestonsburg Community College has long since justified the faith and confidence of its supporters," Dr. A. D. Kirwan, acting president of the University of Kentucky, said last Friday afternoon at a convocation held in the Commons Room of the college prior to the groundbreaking ceremony for the addition of two structures to the campus.

Dr. Kirwan reviewed the history of the community college movement in the United States, the needs such colleges generally meet and the services and programs the college here proposes to afford the area surrounding Prestonsburg in particular.

Describing community colleges as a dynamic, nationwide movement "without parallel," the UK president said 890 such colleges last year had an enrollment of 1,700,000. This year, 950 community colleges have an aggregate student body of 2,000,000.

The groundbreaking ceremony which followed Kirwan's address was made in rain and mud to mark the beginning of a \$1,386,276 construction project which will add to the campus here a two-story academic building and a one-story student activities structure. Officials of the college and the University and members of the college Advisory Board took part. (See Story No. 1, Page 5)

## NEW PRESTONSBURG CHURCH IS EXPECTED TO BE READY FOR OCCUPANCY, FEB. 1st

The new sanctuary of the Prestonsburg Church of Christ, under construction at Lancer, is expected to be completed and ready for occupancy by Feb. 1, the minister, Bennie Blankenship, said this week.

The brick-and-block structure will have a floor area of 4,000 square feet. The sanctuary itself will seat approximately 250, and the building includes six

Sunday School rooms, office and nursery.

Cost of site and building is \$55,000. Construction work is being done by Herman Johnson, McRoberts contractor.

Interior of the church will feature exposed arches and beams of laminated hemlock. A covered entranceway is being provided for protection of churchgoers from the weather.





through the assistance of three student teachers and one teacher aide. As each individual progresses in a group to the maximum level, he is then assigned to another group level.

Although involved in grouping, one child may learn faster than the others. If so, he is placed in his own accelerated program.

The three teachers feel that this individual instruction is vastly superior to other previous practices. "We as teachers in this combined teaching effort, share our strengths together, plan together, and have a better understanding of what we are trying to accomplish with each child," was the consensus of opinion expressed by Mrs. Edna Davis, Mrs. Clara Stephens, and Miss Pauline Hicks.

They also said that individual records were kept on each child in all activities, and these were not sent home as report cards. Instead, the parents are invited to school for periodic conferences on their children's growth.

The multi-purpose of a program of this nature is far-reaching in the school and home, according to Clark.

"Mothers have long realized that their children do not walk at the same time, do not talk at the same time, and do not have teeth at the same time. Therefore, we as teachers accept these same concepts and attempt to meet the individual differences of each child as best we can."

"It is our determination that this procedure will be thoroughly evaluated and, if we find it as effective as it appears to be at this stage, these new practices can be extended upward and outward to all schools in the system," the superintendent said.





## The Only College We'll Ever Have

The groundbreaking ceremony conducted at Prestonsburg Community College last Friday afternoon did not attract the attention it deserved. True, the program was merely symbolic of a work already begun, but the importance of this work needs recognition on the part of Floyd county and its people.

The groundbreaking represented the development of a college campus which is almost certain to be the only one Floyd county will ever have. It symbolized progress toward a student body that could within a few years reach 1,000 or more. One day, as Kentucky's population soars and the demand for higher education grows, it could be a full-fledged four-year college.

This is not a flight into fantasy to speak of a major educational institution, if the people of this area ever make up their minds that they have in this college something that holds for this part of the state and for the young people of the area something worth their interest and service.

Dr. A. D. Kirwan, acting president of the parent institution, the University of Kentucky, was not engaging in idle talk when he spoke of the programs of education and service that are envisioned for Prestonsburg and other colleges of the community system.

These two buildings that are due for completion on the campus here next year involve the expenditure of more than a million dollars. The investment in money here has been no insignificant figure.

Dr. Kirwan said Kentucky now has moved squarely into the middle of this national movement toward community colleges. He pointed out that 42 states have made provisions for two-year college programs and that it is now predicted that half of the high school graduates in the United States will begin their higher education in community colleges.

He listed three factors as responsible for the popularity of these colleges: 1. The open door to all students; 2. Their appeal to people of all ages; 3. The lower cost of education which they offer.

Kirwan pointed to the varied programs already offered by Kentucky's community college system and stressed the vital role they are to play in the technical training of young Kentuckians.

"Technicians," he said, "are not being educated at the rate they are needed. The task of community colleges is well set."

Kirwan said there are 300 specialized jobs in the area of health and welfare alone. The number of specialists required to augment the work of a single engineer has since World War II increased from 7 to 15.

Speaking of the needs which Kentucky community colleges will meet in the individual geographical areas they serve and their growing service to the people, Dr. Kirwan turned to a quotation to define what a community college is:

"A college designed with a community in mind."

Dr. Kirwan was introduced by Dr. Ellis F. Hartford, dean of the Kentucky Community College System, who in turn was introduced by Dr. Henry A. Campbell, Jr., director of Prestonsburg Community College. Dr. Campbell pointed out that the two buildings for which ground was being broken will permit Prestonsburg Community College to offer "many programs we have not had in the past."

The convocation gathering was welcomed by Miss Cheryl Rolston, a student leader at Prestonsburg Community College. Music was provided by the University Chorists, directed by John V. Mochnick.

Following the groundbreaking, wives of Advisory Board members and K-Mates were hostesses at a reception.



In Kentucky, the food stamp program is administered by the Kentucky Department of Economic Security and the commodity distribution program is administered by the Kentucky Department of Agriculture, both in cooperation with the Consumer and Marketing Service.

Foods distributed during October to needy Kentucky families had an estimated retail value of \$700,000. These foods included canned chopped meat, cheese, canned fowl, dry milk, evaporated milk, scrambled egg mix, peanut butter, instant mashed potatoes, lard or other shortening, flour, butter or margarine, dry beans rolled oats, rolled wheat, raisins, syrup, grits and canned vegetables.

Low-income families taking part in the food stamp program during October exchanged \$946,323 of their own money for \$1,763,823 worth of USDA food stamp coupons. This means that these families received \$817,500 worth of free, bonus coupons to increase their buying power at local grocery stores.

# New Lakes Ready For Impoundment

(Continued from Page One)  
The Big Sandy Development District serves Floyd, Pike, Johnson, Martin and Magoffin counties. Formed by executive order of Ex-Gov. Breathitt, it was one of the first among 15 such districts organized in the state.

EDA officials praised the work of Joe McCauley, director of the district office here, his staff and county and city officials and civic leaders for the continuing interest which has caused them to plan and work together.

The Big Sandy district was the first to earn the prized No. 1 designation because it was the first to adopt a comprehensive economic development program. Mr. Francis pointed out that the district development concept is greatly preferred over proposals made by individual counties or towns "going it alone."

Mayor George P. Archer, of Prestonsburg, hailed the announcement of the district's preferred position as "a Christmas present which promises a prosperous new year."

Allan Perry, editor of The Paintsville Herald and president of the Paintsville Chamber of Commerce, spoke of the development program as effecting the gradual reduction of inter-community rivalry and supplanting it with cooperation in planning and effort.

Among others attending the meeting were Allen Pett, director of planning for the Mid-Eastern district, EDA, and Joe Gray, of the Kentucky Program Development Office, Frankfort.

Two new lakes will be formed in Eastern Kentucky next spring when water will be impounded behind the Fishtrap dam in Pike county and the Grayson dam in Carter.

The Grayson Reservoir will be larger than Dewey Lake. Fishtrap will be approximately the same size. But scheduled for completion in 1971 is a major impoundment, Cave Run Reservoir in Rowan and adjacent counties. The lake to be created by this dam will, roughly, be seven times the size of Dewey.

The Licking Valley Courier at West Liberty last week published this information about Cave Run:

The Louisville District, U.S. Army Corps of Engineers, in charge of the construction, announced at Louisville that bids for the Cave Run Dam and spillway will be opened January 16. Also included in this bid are remaining access roads, service bridge to the existing tower, etc.

The successful bidder will have 990 days from the January 16 letting to finish the job. And 990 days from January 16, 1969 adds up to October 3, 1971.

Construction is already underway on what is known as Bridge 1274 20 miles upstream from the dam site, relocation roads, lookout sites, and all other work except the dam itself and the spillway.

The outlet works and tower were completed almost two years ago.

When completed, Cave Run

will inundate areas along Licking River in Rowan, Bath, Menifee, and Morgan counties. The rich Beaver Creek valley in Menifee will be completely inundated.

Seasonal pool will cover 8,270 acres with a capacity of 222,600 acre feet of water.

At flood stage the reservoir will cover 14,870 land acres. Only Kentucky Lake, Barkley Lake, and Lake Cumberland are larger in Kentucky. Drainage area above the dam is 826 square miles.

At places, the lake will be more than two miles wide.

Headwaters of the lake during the seasonal pool stage will reach Mussel Shoals, about 10 miles downriver from West Liberty.

The Courier learned last week that the Corps of Engineers will not buy land for the dam in Morgan County upstream from the mouth of Grassy Creek. Easements will be taken but no purchases will be made, it was learned.



## LEXINGTON CLUBS HONOR FORMER FLOYD WOMAN

Mrs. Bola E. Cottrell, native Floyd woman who is house director and dormitory nurse at the Appalachian School of Nursing, Lexington, is one of three finalists named from a list of more than 20 nominees for the Lexington Business &

Professional Woman's 1968 Woman of the Year award. This is the first year for the three BPW clubs of the city—Blue Grass, Lexington, Inc. and Pioneer—to honor Lexington women for outstanding service to the community. None of the three selected is a BPW member. Their selection was made by a committee composed of Mrs. Mattie B. Sutphin, of the Blue Grass club; Miss Hallie House, Lexington, Inc., and Mrs. Rose E. Bauder, Pioneer. Names of the honorees were announced at the Business Women's Week banquet at which Joe Creason, Courier-Journal columnist, was the speaker.

Mrs. Cottrell is a daughter of Mrs. W. H. Webb, of Langley, and is the widow of Ed Cottrell.

A graduate of the Appalachian School, she is a licensed practical nurse. Her work includes procuring scholarships for young women and men for training in the field of nursing. She has helped recruit inactive nurses to relieve the shortage of nurses and assisted the Fayette Health Department when polio vaccine was given at various schools in 1963.

Mrs. Cottrell works to see that gifts are procured for all orphanages in Lexington at Christmas and Thanksgiving and sees that food and gifts are taken to the Dessie Scott Orphanage in Campton and the Bethany Orphanage in Wolfe county. She sees that each of the 76 children at Bethany has a "Sunshine Friend" who remembers them at birthdays, special days, sends cards, letters and packages. If anyone fails to do this, she personally will see to it that the children will not be disappointed.

Mrs. Cottrell is an officer in the Kentucky State Association of Licensed Practical Nurses, Inc., and works with the senior citizens groups in Lexington.

She is instrumental in the preparation and serving turkey dinner for the children and staff at Bethany Children's Home, members of her group and friends donating all the food, which is taken there by the truckload. She also collected food and clothing for Falmouth following the tornado disaster there.

## UK PROF SAYS ALGAE ON PONDS IS HARMFUL

"Algae, the green scum you often see covering the surface of fresh water ponds, is an enemy of wildlife and mankind," says a University of Kentucky assistant professor of botany who is exploring ways to rid man of this toxic threat.

Dr. Denny O. Harris is a microbiologist who for a number of years has been probing into the properties of various species of algae. He hopes to find a way to inhibit the algae's growth if not actually eradicate it, once it has begun to take a pond or stream.

He has discovered one type of algae which appears to possess inhibitory qualities that can be harnessed to a useful purpose.

"Some fresh water algae actually produce a toxic compound, which when isolated and identified might lead to a process that would free the water entirely from this unpleasant growth, and keep it free," said Dr. Harris.

It has been shown that algae spores can be carried from one body of water to another on the feet of ducks or animals, thus infecting other areas and rendering them unfit for swimming, recreation, or human consumption.

"These spores, upon germination, can be fatally toxic to animals, fish, and at times, to human beings," Dr. Harris said.

"If we are able to synthesize the inhibitory factor so

it could be produced industrially, it could possibly replace other old-fashioned methods with quicker and surer action in cleaning the pond, lake or other water supply."

With the population explosion and the current rational stress on making the greatest use of available fresh water, Dr. Harris' research could lead to the establishment of a definite aid to water conservation research efforts, his departmental colleagues believe.

"Esthetically," Dr. Harris said, "this research can add much to the beauty and purity of water recreational areas. Medically, we can see definite biological indicators which could possibly lead to deeper research and medical applications."

Dr. Harris' preliminary results suggest that these inhibitory qualities of algae also kill bacteria which are harmful to man. The research, which is jointly financed by the U.S. Department of the Interior Office of Water Resources Research and the UK Research Foundation, "was begun as a water conservation project, aimed at protecting our natural water supply, but like many research projects, the new knowledge opens the way to still further research in related fields," Dr. Harris said.

Dr. Robert A. Lauderdale, director of the UK Water Resources Institute, which sponsors more than a dozen research projects related to water use and conservation, said of Dr. Harris' research: "I have great confidence that Dr. Harris' work will be productive and significant, and should stimulate a greater research effort in the area of biological sciences in the future."







## "Candy Hearts" Were Best Of Oldtime Christmases

Frankfort, Ky.—"Children pinned their stockings together and hung them over the back of a chair in front of the fireplace for Santa Claus who would come down the chimney to bring something for Christmas," remembers an Eastern Kentucky man who delights in recalling events of the long ago.

"The children then were hurried off to bed so Santa would come. I would peep from under the quilts to catch a glimpse of him, but I always fell asleep before he arrived. But I know he made it down all right, for early Christmas morning we jumped from the bed and ran to our stockings.

"Those wonderful yarn stockings held such delights for children. There were sawlog sticks of candy, sometimes a doll for a girl, a knife for a boy . . . and candy hearts with little verses of love written on them."

White-haired and jovial, Bernard E. Whit, of West Liberty, who retired several years ago as superintendent of Morgan county schools, explains that "the two biggest things during Christmas 65 or 70 years ago were candy hearts and yarn stockings." The stockings were handmade of yarn spun on a wheel and each child got a new pair at Christmas . . . and always something in it.

"When I was a lad growing up in a log house on Vance Fork, tangerines, oranges and bananas were fruits we just heard about. It was not until years later we were able to en-

joy this Christmas delight. But the fruit was not missed in those boyhood years as long as there were candy hearts.

"The hearts were hollow, about four or five inches, colored nicely and inscribed with the words 'I Love You.' The boys and girls would buy these at the store and give them to their sweethearts. Some men gave them to their wives. There also were smaller candy hearts, about the size of a quarter and of different colors. These had little love verses on them.

"Sometimes we would find an apple in our stocking and maybe a stick of Long Tom chewing gum. I have often wondered why they have quit making Long Tom. It was wrapped in separate sticks in pretty silk paper that no one threw away. It was the best and lasted longer than any gum I have ever chewed."

The retired educator who hikes in his beloved hills, hunts and fishes, likes to believe the true joy of Christmas can be found in a candy heart. "I am sure if people today could find candy hearts with 'I Love You' on them and would give these to everyone at Christmas, there would be the same bond of love and good will that pervaded the countryside in the long ago. It is not the value and number of gifts that make Christmas, but the spirit and love of the giver."





## Mayor's Attitude Held Typical of Development

The Washington Bureau of The Courier-Journal points to what it calls "the metamorphosis" of Dr. George P. Archer, Prestonsburg's mayor, as an example of what Appalachian development could mean to Eastern Kentucky.

The story follows, in part:

Archer is the mayor of Prestonsburg. But in a conversation, he inevitably ends up talking about the problems of the people in other places like Paintsville and Pikeville.

He talks about one neighboring community depending on another. He talks about one community providing services for the other. And he talks about the need for all to pull together.

To Joe Gray, deputy administrator of Kentucky's Appalachian Regional Commission (ARC) program, the Archer story is what the ARC is all about.

"George said at a meeting one night that he always had thought it was every man for himself and every community for itself," Gray recalled.

"But he said he has changed—he realizes that the answer to some of our problems lies in working together. I think that is testimony to the reaction this program has caused."

The Prestonsburg-Pointsville-Pikeville triangle is one of the areas in Eastern Kentucky that the ARC had designated as a growth center—a future concentration of urban development and services aimed at attracting industry and stemming the out-migration of people.

Before that can happen, under the guidance of multicounty development districts working together, some of the more basic essentials are being funneled into the area.

Kentucky put priority on highways, vocational education and improvement of health care and facilities when it began drawing up its Appalachian redevelopment blueprint in 1965.

The gong has been slow, but in several respects Kentucky is ahead of the other 12 states in the ARC. It has more miles of Appalachian highway under construction and it has the largest comprehensive health program, according to the ARC.

This is how the basics are broken down in Kentucky:

**HIGHWAYS**—The state has 413 miles eligible for improvement under the program. Of this, 57 miles has been completed—mostly on KY 15, between Jackson and Hazard. Another 53 miles are under construction, mainly on KY 15 and KY 23, and will be done next year.

Right-of-way acquisition and design is going on for another 254 miles and 49 more miles area in the planning stage.

Money is turning out to be the problem now. It was originally estimated that \$190 million of ARC money would build 90 percent of the system. Today, because of inflation and tougher federal road standards, that same amount will build only 65 percent.

**EDUCATION**—In the Appalachian area, 18 vocational-education schools or extension centers have been built. Seven more are under construction and three are in planning stages. Five more will soon go into planning.

Of major concern to the ARC now is the type of training being provided in those schools. It has put the states on notice that to get more aid, their training programs will have to be more realistically oriented to today's needs.

**HEALTH**—A network of hospital and out-reach services is being developed in the area to provide high-level care at low cost. Projects include home health services in eight coun-

ties, training programs for nurses and other medical personnel, a health-screening program, a program to combat mental retardation, and an area-wide environmental health program. (Nearly half of all the area's health problems are intestinal infections caused by unsanitary water supplies.) The major area of concentration is an 11-county sector in the southeast, where many of these programs are included in a demonstration project operated by the University of Kentucky.

Those three fields—roads, education and health—are deemed to be Eastern Kentucky's principal growth obstacles. The answer to this, the thinking goes, is that a healthy, trained work force will be available for industries that would be attracted by the highways.

"Until we complete the highway system and open the area up to industrial prospects, we can't do much," Gray said. "But once that is gone, we will begin to provide a diversified industrial base."

As Gray sees it, nothing can be very promising unless the development district concept works out. The key to this is involvement of local lay leaders, "developing their own destinies."

## Castle, All-Star End As Military Schools Name League's Best

Mike Castle, son of Mr. and Mrs. Earl Castle, of Prestonsburg and a former Prestonsburg high school football star, has been named to an offensive end position on the All-League eleven of the Virginia Military Schools League.

With the conclusion of the 1969 schedule young Castle ended his first year of play at Greenbrier Military School, Lewisburg, W. Va. Other military schools in the league are Hargrave Military Academy, Fork Union Military Academy and Staunton Military Academy. Fork Union and Greenbrier had identical 3-1 won-lost records, but the former won the league championship by virtue of a victory during the season over Greenbrier.

## OUT-OF-STATE STUDENTS AT MOREHEAD IN 7% DROP

Morehead, Ky., Dec. 13 — A larger percentage of the total student body at Morehead State University is made up of Kentuckians this year than last year. The out-of-state enrollment dropped 7.2 percent from 1,819 to 1,687, while the enrollment of Kentuckians went up 5.6 percent from 4,329 to 4,575 students.

The drop in out-of-state enrollment can be attributed primarily to the increase in fees for out-of-state students from \$580 to \$740 for two semesters which went into effect this fall. The out-of-state tuition fee increase to \$740 at Morehead State University, Eastern Kentucky University, Murray State University, Western Kentucky University, and Kentucky State College, places these institutions \$57 above the median fee charges as reported at the member institutions of the American Association of State Colleges and Universities.

In the fall of 1967, 70.4 percent of the enrollment at Morehead was made up of Kentuckians, 29.5 percent out-of-state students. This semester, the percentage of Kentuckians has risen to 73.1 and the percentage of out-of-state student has dropped to 26.9.

"There is no question but that the increase in out-of-state fees cut back our enrollment as

there were numerous highly qualified students from other states who would have been freshmen here who could not afford the increase in fees," said Dr. Adron Doran, president of Morehead State University.

He added, "Kentucky now charges a higher out-of-state students fee than do the majority of comparable institutions in other states."

Dr. Doran also pointed out that "there was a rather significant number of out-of-state upperclassmen who did not return to Morehead because of the increase in fees." A total of 1,521 upperclassmen from other states returned to the campus in 1967, but only 1,424 returned this fall—a drop of 97 students. This represents a percentage drop of 6.4 in out-of-state upperclassmen.

The fee hike had its effect upon graduate enrollment also as the number of out-of-state graduate students dropped from 62 to 51, a decrease of 17 percent. But the in-state graduate enrollment showed an increase from 300 to 391 students, an increase of 8.6 percent.

The drop in out-of-state enrollment was reflected in the total enrollment this semester which hit a new Morehead high of 6,262, but was only a 1.9 percent increase over the enrollment figure of 6,148 in the fall of 1967.

### Kentucky Veterans To Receive Dividends On Insurance in '69

About 38,500 Kentucky veterans of World War I and II will receive \$2,160,000 in insurance dividends during 1969, Olney B. Owen, manager of VA's Regional Office in Louisville, has announced.

Payments begin January 1 and will continue throughout the year on the anniversary date of each veteran's policy.

Thirty-seven thousand World War II veterans will get \$1,950,000 on their National Service Life Insurance policies for an average of about \$53. The remaining \$155,000 will be divided among 1,600 World War I holders of U. S. Government Life Insurance, averaging about \$97 each.

Nationwide, 4,250,000 veterans have retained their GI insurance and will participate in the \$236,000,000 dividend distribution.

The VA will pay a modest, first-time dividend averaging \$11 to approximately 193,000 (about 200 in Kentucky) veterans holding modified life insurance policies. These policies are issued at a low permanent plan premium rate and provide maximum insurance protection until the veteran reaches age 65. Then the face value of the policy is halved.

Payment of the dividend is automatic. There is no need to apply for the dividend, Owen added.

## KEA DELEGATE ASSEMBLY TO MEET IN LOUISVILLE

Louisville, Ky.—The Kentucky Education Association (KEA) Delegate Assembly will meet here January 10 and 11 to develop and adopt a legislative program for the 1970 session of the Kentucky General Assembly.

The call for the special meeting of the more than 600 delegates was issued by Mrs. Martha Dell Sanders, KEA president and coordinator of the professional improvement program for Paducah public schools.

Delegates will meet at Louisville's Ahrens Trade high school, at First and Walnut streets opposite KEA headquarters. The January 10 meeting will begin at 7:45 p.m., EST, and the January 11 meeting at 9 a.m.

KEA traditionally formulates its legislative program in advance of spring primary elections for House and Senate seats. Mrs. Sanders noted that decisions made at the January meeting are subject to modification at the regular April meeting of the Delegate Assembly, KEA's policy-making body.

Fred Bishop, of Manchester, has been elected temporary chairman of the new Legislative Commission of the Kentucky Education Association.

Commission members also elected Oz Johnson, Louisville, as temporary vice-chairman. Verne P. Horne, KEA director of public relations, was named KEA staff consultant to the commission.

The Legislative Commission was established this year by the KEA Delegate Assembly in line with recommendations of a KEA structure study committee. Commission members, one from each of the 11 KEA districts, were elected at fall meetings of district education associations.

Bishop is director of pupil personnel for Clay county schools. Currently a Republican state senator, he was assistant minority leader and chairman of the education committee in the Senate during the 1968 session. He was chairman of the Senate education committee in 1962. He is legislative chairman of the

Clay County Education Association, is a former president of the East Kentucky Tourist Industries Council and former district deputy grand master of the Grand Lodge of Kentucky.

Johnson is assistant superintendent for research for Jefferson county schools. He was a Republican member of the Kentucky House of Representatives from 1962 to 1968, serving as a member of the House Education Committee, was chairman of the Republican Joint House-Senate Education Committee from 1966 to 1968.



## FINAL REGULATIONS UNDER THE NEW FEDERAL GUN LAW

The publication of final regulations under the new Federal Gun Law was announced last week by the Internal Revenue Service. They will appear in the Federal Register of December 14, 1968.

The new Gun Law does not prevent sportsmen from buying firearms and ammunition in the states in which they reside. However, the sale and delivery must conform with state and applicable local laws. In addition, a retail purchase will usually have to be made in person and the buyer will have to show sufficient identification, such as a driver's license, to establish his name, address and age.

The major restriction on sales in the new law forbids residents of one state from buying firearms, but not ammunition, in another state. One important exception to this rule permits a resident of one state to buy a rifle or shotgun, but not a handgun, in an adjacent state if certain procedures are complied with. The purchase can be made only if the buyer's state of residence enacts legislation that permits it to take place and the sale is legal in both states. A sworn statement in a prescribed form must also be forwarded to the chief law enforcement officer in the purchaser's place of residence and be acknowledged by him.

Licensed collectors, who are limited by the Gun Control Act to transactions in curios and relics, will find in the regulations the tests for determining whether a gun falls into this category. The regulations also point out that clubs furnishing ammunition to be used on their premises in skeet, trap and target shooting activities may do so without a dealer's license. The ammunition may also be furnished to participants under 18, though the new law prohibits sales of guns and ammunition

to anyone below that age, such transfer not being considered a sale.

Included in the regulations are details on the preparation of the records to be completed by a dealer for each firearms transaction. To further aid dealers in complying with the new law, illustrations or required firearms and ammunition acquisition and disposition records are shown.

The regulations implement those sections of the recently enacted Gun Control Act of 1968, that go into effect December 16, to provide firearms and ammunition control assistance to federal, state and local law enforcement agencies in their fight against crime. They also cover part of the earlier enacted Omnibus Crime Control and Safe Streets Act of 1968 dealing with the unlawful possession or receipt of firearms by persons such as criminals and fugitives from justice.

### Financing of Building For Hazard Arranged At Commission Meet

The Kentucky Commission on Higher Education last Thursday took action which in effect completes the financing arrangements for construction of the University of Kentucky's Hazard Community College.

The Commission, meeting in Frankfort, approved UK's application for a facilities grant of \$52,735. Actually, this is a recommendation that a grant of that amount be approved by the U. S. Office of Education in Washington.

Robert F. Kerley, UK's vice-president for business affairs, emphasized that federal approval still is required before the grant becomes official.

The Commission also amended a plan by which federal educational facilities funds are allocated. The amendment brings the state plan into conformance with a recently amended federal law that increases the amount that can be granted for community college construction to 50 percent of eligible cost. The previous limit on such grants was 40 percent.

This action, said Kerley, means that the University may now file a supplemental application to the Commission on Higher Education for an additional grant of \$138,184. This would bring UK's total grant application for constructing the Hazard college to \$90,919, or 50 percent of that portion of the building's cost which is eligible for federal assistance.

The U. S. Office of Education already has approved UK's loan request for an additional \$426,000 to be applied to the cost of the Hazard project. The total amount thus expected in federal funds, including loan and grants, is \$1,116,919. Kerley said the balance of the project's estimated \$1,528,184 cost will come from University revenue bonds.

### Social Security Bldg. Bids Being Sought

Bids for construction of a new district office building for the Social Security Administration at Pikeville are being solicited from small business concerns by the Chicago Regional Office of General Services Administration.

The project involves construction of a one-story building without a basement on a site at 421 Second Street, Pikeville. Exterior walls will be brick and concrete block. Interior finish will be drywall with demountable partitions for office enclosures. Also included in the project are exterior utilities, roadways, walks, parking and landscaping.

The estimated cost range of the project is between \$155,500 and \$173,500. The anticipated completion time is 240 calendar days.

Sealed bids will be accepted until 2 p.m. CST on January 9, 1969.

### TIDBITS of KENTUCKY FOLKLORE

By GORDON WILSON, Ph. D.

Two of my favorite American authors, about whom I never tire of reading, whether in their works or in the numerous studies that have been made of them, were John Greenleaf Whittier and Oliver Wendell Holmes. Of entirely different backgrounds, they grew more and more close together as they passed middle life and outlived nearly all of their generation. Both were still alive when I was born. Whittier dying in 1892, Holmes, the "last leaf" of his generation, in 1894.

In religion, at least superficially, they were vastly unlike. Holmes, raised in a very orthodox family, became one of the most liberal religionists of the nineteenth century. Whittier was from a line of humble Quakers, and he remained, outwardly at least, an Orthodox Quaker to the end of his 85 years. After Holmes, broadly educated for his time, both in America and in Europe, came to maturity, he grew in love for humanity and in tolerance more and more like Whittier, whose formal education included only what was taught in the one-roomed school in his neighborhood. And, be it said to their credit, each one had sacrificed a promising career as a politician to plead for abolition, when it was not only unpopular to stand out for this reform but was positively dangerous — even in Massachusetts. Holmes, realizing how much human suffering there is because of lack of sanitation, was a pioneer in what we now take for granted, sterilized instruments in surgery. He is still recognized as a valuable scholar in that field. I have been told by several of my former students that his essay on what used to be called "childbed fever," really blood poisoning from lack of sanitation, is required reading in many medical colleges. The whole field of medicine and surgery were uplifted by Holmes, the great teacher in the Harvard Medical College for a long number of years.

Naturally since my own years have been many, I have loved to read about the older years of these two fine men. Holmes, though a small man, retained into advanced age the agility of his youth. A great walker, almost a fanatic about rowboats, always popular in social circles, he somehow outlasted all his contemporaries. Whittier, who spent more than 60 of his 85 years as a semi-invalid and who had to watch almost every day of his life to see that he did not overwork his frail body, kept vigor of mind and did not allow an ailing body to bring ailing thoughts. For years on end he had to limit his reading to less than an hour at a time, and writing, by which he made his living, brought headaches that the medical science of the time did not know how to treat. Some of his friends called Whittier the Hermit of Amesbury, and, as compared with the socially active Holmes, he seemed just that.

In watching old people for a long lifetime, I have tried to see how they face old age, whether they give up the fight. The typical folk attitude is to lean heavily on human sympathy by airing one's obscure aches. Many

a man whom I have known had given up by or before he was 60 and recalled two things, frequently for another 20 to 30 years: 1. the Good Old Days and 2. the time when the next pill or powder would be due. I have seen some oldish men who must cause they would be taking five have had great memories, be- or six kinds of stuff every day and seemed to welcome a visit to the doctor. Since I have had to report for nearly 30 years to have by golly examined, I have had innumerable opportunities to see the same old fellows awaiting their turns to "see the doctor." Several other oldsters, many of them far older than the ones who frequent the doctor's office, can be found only at some place of business or on the street, going about whatever they felt they should be doing. Maybe both types enjoy life, maybe the sick ones are just as sick as they think they are, but I cannot help enjoying more the bouncy old fellows who, even though they may not get around quite as well as they used to, are still active, still standing up, facing old Father Time, not running away from him.

### INCOME OF MINISTERS AND SOCIAL SECURITY STATUS ARE REVIEWED

Income from the ministry will automatically be covered by social security for taxable years ending after 1967, unless the clergyman receives from the Internal Revenue Service an exemption on the grounds that he is opposed to coverage by reason of conscience or religious principles.

Clergymen who elected coverage under the previous law will continue to be covered without taking any further action.

They will be treated as "self-employed individuals" under the law and will report their income and make their tax contribution as if they were self-employed even though they may be performing such service as employees.

If a minister who had not already chosen to come under social security before 1968 does not wish social security coverage, he must file an application for an exemption and a statement that he is opposed to receiving social security benefits based on service as a clergyman by reason of conscience or religious principles.

The application must be filed with Internal Revenue Service by April 15, 1970, unless he enters the ministry in 1969 or later, in which case he will have until April 15 of the second year after the year in which he be-

came a clergyman to request exemption. Once an exemption from coverage has been received from the Internal Revenue Service it cannot be withdrawn or revoked.

The new provision does not affect members of religious orders who have taken a vow of poverty. As before, they are not covered by social security.

A clergyman covered by social security is, during his working years, building up valuable protection that will pay him and his dependents cash benefits should he retire or become disabled. He is also building valuable protection for his dependents in the event of his death. He is building valuable protection against costly hospital bills when he gets older.

### Questions and Answers

**Q.** I receive a pension from the Veterans Administration. With my November check I received a questionnaire regarding my income for 1968 and 1969. Since my income is what I estimated on last year's questionnaire, must I return this questionnaire?

**A.** Yes—it is particularly important that you return the questionnaire you received in early November.

The VA will inaugurate a new pension system on January 1 which will raise income limitations \$200 and key pensions to \$100 variations in income. Thus, the VA must receive your completed income questionnaire in order to determine how much of a pension under this new system you are entitled to receive.

Your questionnaire must be returned to VA by January 15 if you are to continue receiving your pension.

**Q.** Can I receive Veterans Administration benefits for flight training under the War Orphans Educational Assistance program? I have my private pilot's license.

**A.** Flight training is not approved under the War Orphans Educational Assistance Act. Therefore, the VA cannot pay you any benefits for flight training.

he receive it for the rest of his life regardless of his income?

**A.** Compensation payments do not depend on income, but rather on the nature of the disease or disability. Some conditions would be subject to change while others would remain static.

On conditions subject to change, the veteran might be examined periodically, and his compensation adjusted accordingly if his condition has changed.

A veteran may reopen his claim at any time by submitting new and material medical evidence to the VA. This evidence could also change a previous static rating made by VA.

**Hands and Hearts of Santa Are Many**

Frankfort, Ky. — The Santa Claus who comes to visit almost 5,000 patients in Kentucky Department of Mental Health hospitals has thousands of hands and hearts and a bag spilling over with boundless generosity.

This Santa — women's clubs, church groups, youth clubs, union locals and individual people with big hearts — makes Christmas as homelike as possible for the retarded children and mentally disabled adults at the six hospitals.

They are: Eastern State Hospital, Lexington; Central State Hospital, Anchorage; Kentucky State Hospital, Danville; Western State Hospital, Hopkinsville; Frankfort State Hospital and School for the Retarded and Outwood State Hospital and School for the Retarded, Dawson Springs.

Santa comes bearing gifts, at least one and often as many as three or four for every patient. The gifts are donated along with wrappings by groups and individuals.

In addition, the volunteer groups and clubs hold parties on the wards — fruitcake and ice

cream, a rollicking Santa distributing gifts and community singing. Wards are gaily decorated. Church choirs and caroling groups often sing at the hospitals.

At Eastern State, nativity tableaux are held on the wards, with the hospital chaplain telling the story of Christmas while patients act out the scene.

Also at Eastern, patients have the chance to send out their own Christmas cards.

Patients at all the Department of Mental Health Hospitals go on night bus rides to see decorated homes in the area.

At Western State, patients help build a float for the downtown Hopkinsville Christmas parade. This year, a gigantic elf waved and smiled his way to a blue ribbon as more than 300 patients watched from the sidelines.

Gifts for patients at Western are coming in from all 33 counties the hospital serves.

The kids at Frankfort State Hospital and School will be treated to the Wayne Taylor Christmas Show by the Jefferson County Board of Recreation.

Again this year, the staff of the Frankfort central office of the Department of Mental Health will forego the usual gift exchange among themselves and instead collect gifts and put on parties for three wards of severely retarded youngsters at the hospital.

At Outwood, last Christmas was a spectacular affair and officials there expect an even bigger one this year, with participation from church and community groups throughout western Kentucky.

Gifts and cash to buy them, have been pouring in for Outwood's 430 retarded children.

Santa's helpers at the hospitals, the volunteer service coordinators, handle the logistics of wrapping and distributing thousands of gifts and holding scores of ward parties at Christmas time. The coordinators say they try to individualize patients' gifts as much as possible, giving everyone something he asked for.

All the hospitals say they could use some help from any one who cares to drop in or send a gift.



**New Law To Control Gun, Ammunition Sales**

Sales of guns and ammunition will be controlled under the new federal gun law which takes effect December 16.

Robert J. Dath, district director of Internal Revenue for Kentucky, said this week IRS is preparing material to help gun dealers, gun buyers and collectors comply with the new Gun Control Act of 1968 which was enacted by Congress in October.

Mr. Dath said the new law should not place any unreasonable restrictions on the purchase or ownership of ordinary guns used for hunting, target shooting or other lawful purposes.

Persons under 21 will be prohibited from purchasing pistols, revolvers, and ammunition for such weapons and persons under 18 will not be permitted to purchase any firearms or ammunition.

Sales will generally not be permitted to out-of-state residents, Mr. Dath said, although a person from an adjoining state can buy a rifle or shotgun by complying with certain provisions of the new Act. Sales to residents of a state will be prohibited if possession of the firearm is not allowed by local ordinance.

**'Whatsoever Things'**

Wilson Thomas Turner was sitting at the bar. The date, September 12, 1964. The place was Bradenton, Florida. "One more little drink won't hurt anything," he could have thought. Turner took one more little drink. Maybe it was one for the road. Then he ordered another bottle to take home. It's always good to have a bottle around the house, isn't it?

Turner got up from his seat, turned and walked through the door. He got into his automobile to drive home. He had done it before. Like most folks, he thought a little toddy wouldn't affect his driving. Some folks, you know, think they do their best driving with a shot or two under their belts. He opened the door and sat down behind the steering wheel. Then he headed down the road toward home.

Turner had had a hard day. He was looking forward to seeing his son, Randell. Randell was in the fifth grade now. He had grown up so fast. Turner was proud of his son. He always liked to spend some time with him.

The automobile roared down the street. The speedometer went higher and higher. Turner didn't notice the speedometer. Maybe like a lot of other folks who drive after a shot or two he was an expert driver. Suddenly, from out of nowhere, came a kid riding a bicycle. Turner turned, applied the brakes. He waited for a split second. Then he heard a loud thump. He looked back. The kid was on the pavement. He sped away.

Witnesses at the scene identified the car. Officers found it later at the home of Turner. The blood was still on it. They found Turner in the attic, a bottle in his hand. It was the bottle that was good to have around the house. Officers questioned him for more than an hour. Then the news came. The boy was dead. "He just went to pieces when he was told the boy was dead," said Sheriff Ken Gross.

Turner was taken to jail. He was charged with manslaughter and leaving the scene of a fatal accident. His attorney, Jerry Hussey, carried him a Bible. He sat in the jail reading the Bible. "He has sworn up and down to his wife and me that he'll never touch another drop of liquor," said Mr. Hussey.

Turner was allowed to leave the jail long enough to attend the funeral service for the boy. It was one of the hardest funerals Turner ever had to face. The minister tried to bring comfort in such a trying hour. They carried the casket to the grave and lowered it into the earth. The life that Turner had taken

so foolishly. Nothing anyone could do would bring the boy back.

A little drink never hurt anyone? Turner couldn't say that now. Because it had hurt, so awfully hard it had hurt. If only there was another chance. But it was too late now, too late.

The story is true. It was carried by UPI. There is one other item in the story. The boy Turner killed was Randell Turner, his 12-year-old son.
