I have received your letter of the 13th with copy of bill of J. N. Harris attached. I give below such information as I have in regard to the items of the bill and the items from a previous bill mentioned in the last paragraph of your letter.

(1) Two certified copies of deeds. May 15, 1914.

I can not identify these deeds from the information given or say whether or not the originals or the certified copies from the County records charged for are in my office.

(2) Recording deed from W. H. Layne to Gibson Coal & Coke Company.

I have a deed, dated February 23, 1914, from Will H. Layne, Master Commissioner, Floyd Circuit Court, to Gibson Caol & Coke Company, recorded June 5, 1914, Book 40, page 501, which I take to be the deed referredto in this item. It covers the Ellis and Milton Ramsey tract (BC-1069 & BC-1163: our B-5) and was delivered to me some months ago by Mr. Combs. The charge for recording is not noted on the deed but it is marked in pencil "Charge to Elk Horn Fuel Co." (This is the intermediate deed in the transfer of this tract to the E.H.F.Co.; the final deed from the Gibson Coal & Coke Co. is being held by Mr. Combs for the payment of \$200 reimbursement on purchase price.)

This deed is in my office. It is dated July 16, 1915, recorded August 2, 1915, Deed Book 44, page 324. This is the final conveyance to the Elk Horn Fuel Company of the Clell Haynes tracts on Toler's Creek, (E-6 and E-7)

This matter was handled by the Legal Department and the Land Office has not been supplied with the bond or copy.

This deed is in my office. It is dated February 16,1915 and recorded March 16, 1915 in Deed Book No.44, page 147 et seq. Tax & Fee \$4.45.
